I wrote him an email telling him I wanted to file a restraining order if he did not leave me alone and that there was plenty of work – he just had to back off of me and stay out of my physical space. I still have a copy of that email.

I was tripped on a set in January of 2008 and had both my legs knocked out from under me right around the time this was happening. I could not bend my legs for a week. Within 8 months everyone stopped hiring me. I have never been treated the way this town treated me before ever. I passed a background check to work for the census, and not only that they sent me documentation because they terminated me for lack of work. However, I am against the war and will never work for them again. I hated it and I have a BA in acting, and an MA in working with performing arts groups but not as a manager or producer.

I show up and I am told that I can never work at ABC again on a lot with a stand in from Carnivale. My rights have been violated. I do not care about fame but I did care about my reputation on sets and my work and I worked on 200 productions in this town. I DID NOTHING WRONG. I NEVER WOULD. I have an email from Blake Shields telling me he liked me but he had a girlfriend and I told him that Jeremy was assaulting me and I wanted someone, anyone, to stop him. I do not cheat and guess what- never interested in Jeremy. I am sorry but I've never done a drug in my life. I graduated from college a virgin and what really makes me sick is you went to the same school I did and I had my ex boyfriend stalk me on MySpace and that bastard also tried to do the same thing that your boyfriend did and when I stopped him because I was not ready to lose my virginity broke up with me. I think you both are sick with your anal sex tapes and I hope Jeremy gets help for his abusive tendencies. Part of me wishes I had not stopped him from trying to jump out of that car that day when he was drunk or high. Maybe then I would still be on sets and I would have a reason to fight to work to live.

I do not work unless on a set and I will not go away or get a job. I only had one job to live for. I retired from the law. I WILL NEVER USE THAT DEGREE. Los Angeles is my home and I have no car anymore to go anywhere. I have told SAG everything. I mean everything. I did not deserve this. I was studying Photoshop and digital media and if you studied with Kelly Holoski back east and talk to her, remind her I taught myself studio 8 and that I loved acting so much I lived at the theater for most of my days in college because I was constantly either working on a play or helping out on one. I did not become a major until my second year and had to take the maximum credits to finish a dual/double. After I left, my ex suddenly started hanging out there. Kind of sick to me. I worked for the college communication department in chard of the film equipment for a year for free because I was on a full scholarship and you guys think I am going to go back to DC to be in an office. The internet is a powerful tool- Id never let your man be forgotten for what he did to me and considering I ran into him in Pasadena on the street and heard him say- she is supposed to be gone she is fired. I have an abusive father and my college friends were the sons of the dean and president of the school- and their parents used to let me stay on campus so I would never have to go home.

I want my right to work on any studio lot and to audition with casting. I am not CRAZY. In fact part of me is grateful. I've done more real acting these past two years than anything else. I am that good. I am also honest though. I will not lie to get ahead and I will not cheat or be dishonest. I did graduate a Maryland distinguished scholar from college and I did work for Court TV. I only have one future I chose to live for when I had cancer. I did not see a future for myself past law school until I moved out here and started working on sets. I will never ride a bike or run a marathon. I cannot dance for long and I've put up with enough pain. Hell I took a few dancing classes and ended up hurting myself to the point I could not feel three of my toes. That is no reason to not be on sets anymore. I have fought to walk twice and I have no interest in being in contact with anyone who does not accept I am an actress. I chose to live because I loved just being a background artist. I lost BOTH My breasts to cancer and I would no problem what so ever showing you or anyone my cancer scars. I think this is such a farce. You and your boyfriend have videos of anal sex porn in your apartment, something I have never done, or ever will, and I'm the one being treated like a monster. THAT IS INSANE and to me both of you are perverted and crazy. I had a young 20 something guy break up with me when I first moved here because I was not bi- which is fine if you or Jeremy is. But that is not my lifestyle and should not be a requirement for me to work. Why I do not date guys more than 10 years younger than me, and I took a vow of celibacy until I am on my own working for myself and acting.
