Dear Amal:

My name is Laura Ann Tull. You do not know me, but I worked on sets with your husband. I am not certain he knows me. I also worked for ALVIN SNYDER who edited the documentary used by your husband for "GOOD NIGHT GOOD LUCK." I am experiencing slander, abuse, discrimination and it is all wrong. I did not do anything to deserve all of the pain I am in. I am very sick and my life is on the line. I am being put in a position where I could end up on the streets of Los Angeles. I have nowhere to go. My life was about acting. My family is abusive. I am terrified and alone. I am innocent of doing anything criminal. But I kind of suspect your husband's friends may think otherwise. I want you to know straight off. I was sexually assaulted by Jeremy Gilbreathe, and Jordan Marks who is now a lawyer for ANNAPURNA PICTURES, came after me on a set to date when he was 18 and he got me drunk and I am not a sexually aggressive woman. I am also however not a woman desperate for the attention of men. He lied to me. It was one night in 2003 and I moved on. I now know he is affiliated with JULIA STILES who apparently expressed a desire for me to be GONE. I did nothing to JORDAN and I do not deserve to be destroyed. This is the year 2021 and so he wanted to sleep with me and I was not that into him. Jordan knew I had a law degree and was older. I passed out on him. I remember he had a condom. To put it bluntly, I am not a complete prude, but I am also not the kind of woman who is slutty or sex obsessed. In college they called me the Virgin of the Theater.

I have a Juris doctorate from Catholic Law School, theater economics degree from McDaniel, and a Masters in Performing Arts Management at American University, certificate from American Academy of Dramatic Arts, and a Certificate from Santa Monica College given to me in 2018 in Digital Media. Yet due to illness and abuse and slander I have been unemployed since 2010. I lost my breasts to Cancer in 2005, my doctor was Kristi Funk. I was sexually assaulted in 2006 by Jeremy Gilbreathe after a mastectomy. I was tripped on the set of the Paramount film "The GOODS" in 2008. I joined AFTRA in 2010 and was assaulted by staff Consuela Flores, and they gave me my money back. I joined SAG in 2011 but the UNION had the police put me into an institution in 2012. It was not because I was suicidal. It was because I said I was a lawyer and someone told the police I said I would get a gun. My father is a gun collector. I hate his guns. I would never get a gun. I have played a cop on television but I have actually only fired a gun two times in my life. I was the ABA representative for Catholic Law class of 1998 and CRABTREE IRELAND the lead lawyer for SAG AFTRA was the ABA representative of Davis law school also class of 1998. I think he knew I really was a lawyer. I have had a lawyer with the state bar of California tell me that I cannot say I am a lawyer. I cannot say I am an attorney. But I did graduate law school. I now think that the LAWYERS are part of this conspiracy to destroy my

name and stop me growing and working in the entertainment industry. I am being told I am crazy and not a lawyer, but I have law school debt that seems to indicate I did go to law school. From my view the lawyers with the state bar are corrupt as are the lawyers with SAG AFTRA. I filled actions against SAG AFTRA, SHONDALAND, ABC, DISNEY, SAG FOUNDATION in 2014 only to have the cases thrown out and to spend years being trolled online on Twitter. The person threatened to slash my face and rape me. I filled complaints with the FBI and they did nothing. I have screen shots of many of the attacks. Much of this is post on my website lauraanntull.com. THERE WERE over 100 accounts created. I have repeatedly tried to get legal help only for lawyers to drag their feet or to promise me help and then drag out the case to no end.

Most recently I was kicked off Twitter but I believe that the removal was unlawful and I was targeted. I suspect that the same person who trolled and threatened me for years on Twitter may be the same person who had my Twitter account shut off. I had over 1600 followers. It was not a lot, but I was not looking for large numbers. I was after quality and not quantity. It turns out this person is in the United Kingdom. I have actually emailed the police in the United Kingdom telling them about this person who goes by CASSANDRATAYLOR1980@hotmail.com. She wants me to stop involving other people in my sexual assault and to stop telling people. She also says she knows why all of this is happening to me and it is all my fault. She says I am a criminal but I have never committed a crime. I am unemployed because of these insane lies. I have two twitter accounts. Lauraanntull & Artistichope

I think this is all crazy. I am a girl that wanted to build an acting career but I did not care about the lives of Celebrities. I also was working to do other things in the industry. I trained to judge scripts and write scripts. I trained to be a film maker. I trained to be a director. I have created online content. I can edit digital film. But I have been convinced by this troll I have nothing to contribute to actors and it stopped me caring about everything else. This troll said they were working with actors to create content. They seemed to know about events only SAG members would know about. They at one point made fun of me for not being at an event at the WB. I was invited to a horror film at the WB and did not go. I should have the right to work to be an actor. Instead I feel like it is now an exclusive club and I do not have the right to be an artist and it makes me feel like everything I learned about America is a lie. I built a web site about the arts but I was not making any money off of it. I wanted to build it into a blog business but this person does not get taking me off twitter completely isolated me.

I was sexually assaulted by JEREMY GILBREATHE who was a stand in for NICK STAHL on the set of CARNIVALE. Your husband may know NICK. He was in a film with him called the THIN RED LINE. Will Wallace, one of my acting teachers, is also in that film. Wallace and I are not friends. IN fact I was in a film Wallace directed and recently he removed the credit from IMDB. I still have the script. The assault happened in 2005 2006 after I had a MASTECTOMY. Gilbreathe shares credits on IMDB with BEN AFFLECK "Pearl Harbor" and his friend KEVIN SMITH "Method in the Madness." It is a UK film. I do not do drugs. GILBREATHE has a cocaine problem. According to an email I received from a friend of GILBREATHE Joe Arias, Gilbreathe blames his cocaine addiction for assaulting me. It is no excuse. I did not want him in any way. I went clubbing with him as a friend and asked him to drive me back to my car, instead I was driven to a house in the hills and fell asleep on a sofa. I woke up with Gilbreathe's hand down my pants

shoving his fingers up inside of me. It was not an act of intimacy. It was an act of violence. Disney is hiring Gilbreathe. He has recent credits with NATIONAL GEOGRAPHIC, which is now Disney.

I met Affleck in 2018 at AGAINST THE STREAM. I had been at Against the Stream before. I often sat with the PRODUCER DENISE DI NOVI, Mary Stancavage, Michael Zittel, and others. However, I rarely sat with Noah Levine. At the time I met AFFLECK the only thing I had to talk to him about was George Clooney. I kind of am not a fan of AFFLECK. I never saw GIGLI and only recently saw ARGO. I grew up with parents who are GOP and I left their religion at 18. I converted to Catholicism in 98 and left the Catholic church in 2011 though I started getting into Buddhist meditation in 2007. I am for the UN Humanitarian Bill of rights which clearly states that people have the right to change their beliefs. I do not change my beliefs for other people.

I was tripped on the set of "The GOODS" in 2008 Within 8 months I was fired from every background casting agency. There were people on that set who knew Jeremy Gilbreathe, including J.T. who was Tim DeKay's Stand in. I did not cause that accident. I was told to run or I would be fired. I think I was tripped. The film was PARAMOUNT but DISNEY was the company blacklisting me. Disney was the common factor. ELI STONE DISNEY. DESPEARATE HOUSEWIVES, and a film called BEDTIME STORIES starring ADAM SANDLER. I wonder if GILBREATHE worked as a stand in for SANDLER. And SANDLER is GOP. Certain background artists spread rumors I was crazy and I did not really go to law school. I was never practicing law. I was not cut out to be a lawyer and had worked in news and for COURT TV in law school. I came to California to pursue a career in acting and production. Instead I was assaulted and abused and now I find myself being slandered as an aggressive woman to protect the man who tried to rape me. The man who assaulted me JEREMY GILBREATHE is married to a woman he was dating at the time of the ASSAULT, ALAINA FILO. She went to the same college I did but graduated in 2002. I am the same age as MATT DAMON. I do not cheat. Jeremy apparently has told his friends that his cocaine addiction made him do it. Also that for some reason I am at fault to. I did not want him. I do not have any STDS. I never slept with anyone underage. I also never attacked anyone including the ACTRESS CARRIE FINKLEA. Carrie at Santa Monica College used me as an extra in a short she made in the first class I worked with her. She later went to Italy to make a movie. I had one class to finish a film certificate and I just wanted to take film 33 and quit the school. Instead they had security run me off the campus, yet I told CARRIE I did not want to work with her because she yelled at me on a set. I feel like I am living in nightmare where I am being lied about and destroyed. From my view this is evil but apparently someone wants everyone to think I am the villain in this. I AM NOT.

I was pulled off of ELI STONE in 2007 after COURTNEY LOVELL found I had an email from BLAKE SHIELDS an actor who wrote a play in 2013 called "Double Bind" and he named the characters in the play, LAURA FRANK AND SAM. I have ex boyfriends named FRANK AND SAM. In the PLAY LAURA desperately wants to hold on to her husband with a real job, at least according to the reviews. I have never seen the play. Blake was an actor on CARNIVAL and knows JEREMY. He is ISRAELI and American. I have been trolled and attacked repeatedly by Christians and Jews. I am 2% Jewish. Please note that both of the leaders of DISNEY are JEWISH. I am not anti Semitic. Someone however did not like that a WASP like me was asked out by BLAKE. They

even called me a WASP on twitter. IRONY I hated my parents church as a child. I felt it only cared about MONEY and not the planet. I now have found an interview with Blake in which he sounds like a misogynist. The way he talks about rape and sex is offensive to me. An actor named ALEX SOLOWITZ trolled me on twitter 2019 and sent me nasty messages on twitter at the time I was filling charges with the state and just before I found out officially that my charges were dropped again. I do not think that was coincidence. ALEX is in the same episode of NCIS as BLAKE SHIELDS.

I am now getting emails from a woman who says she had me banned from TWITTER. This just happened in MAY. I said I hoped GILBREATHE suffered as much as I did. That is not a direct threat. This woman appears to be in the UK and goes by the email CASSANDRATAYLOR1980@hotmail.com. She says I cannot sue her. She also is telling me to stop emailing people about JEREMY. I am being silenced. I have the right to speak out about this crime against my person. She is saying I was aggressive on sets. I do not know this woman and that is not true. I know I was terminated from sets because Central told me their client said to get rid of me. Well the client of all the shows was DISNEY. JEREMY GOT MARRIED In 2014 at DISNEY. I feel like I am being victimized by someone like STEPHEN MILLER, Trumps right hand. I do not like TRUMP. I am a DEMOCRAT. I grew up in Maryland. MY parents ARE GOP and I do not want a relationship with them. I am being stalked my GOP Christian men on line and I will not build a relationship with them. CASSANDRA TAYLOR says I am evil and nasty, but I am a woman living in 2021. I am a woman who wanted an acting career, but I would not sleep with anyone to get ahead and I am not interested in being with a man who I do not like. I moved out of my parents house at 18. Taylor claims she is not discriminating against me but her language of HATE says otherwise. She has even said I do not deserve children.

Since 2006 I have been celibate and I wanted a guy I could have a family with but I also wanted my abusive parents out of my life and for me to have a happy life and career. I have been treated as if my wanting to work in the industry and be an actor was a crime and it just makes me feel like I am living in a dystopian America. I kept getting men contacting me who were Christian and my social media clearly says I am secular. I also wanted FRIENDSHIP FIRST. Now it is too late for me to have that family and yet the people doing this to me are trying to say that I am evil. They want me to be silent about what GILBRETHER Did to me and make me give up everything I love to do and want to do with my life. I love acting and poetry and film making. I do not like law or politics. I do not want to have a guy with a real job. I think the AMERICAN DREAM is a cage for women to be imprisoned in.

I want you to know I created a website about the arts. ARTISTICHOPE.com. It was not so I could give up acting. It was so I could get out into the world and do positive things for the arts. I had a twitter account with over 1600 followers @lauraanntull and I did not want more and had spent years building up a community. Someone came after me and took it away after I said I hoped GILBREATHE SUFFERED as much as I have. THAT PERSON actually contacted me to tell me they did it. She is using the account CASSANDRATAYLOR1980@hotmail.com Who ever she is she does not get she is destroying my business because my business is ideas and not products. I do not sell things. I am an actor and creator and artist. She has taken away years of me putting myself out into the universe to be seen.

Shondaland is a part of this. Shonda Rhimes company. Jason Winston George is a Christian Actor who was born in Virginia Beach and he was cast on Eli Stone after I was working on that. I had been working on the set of Grey's Anatomy from 2005 to 2008. I was in the PSA for Stand Up 2 Cancer in 2008. Arne Star a background artist who I now know was also working crew was a work "friend" but he got misogynistic with me. He sent me emails calling me a schizophrenic. He is a cartoonist. I now know he is featured in a film made by Weinstein and Annapurna Pictures called "the Master." In 2008 I was working on Grays Anatomy and I was told to come to work on a MONDAY morning in August. It was the week that they announced your husband was in a film playing a fixer telling people they are fired. Well that is what happened to me. SOME older man who looked like a school principal at the gate of Prospect Studios tells me that I am on a WATCHER list by Disney and I am banned from the lot. It was a MONDAY MORNING and they had all weekend to tell me they did not want me to come to work. I had heard PATRICK DEMPSEY and ERIC DANE talk about me the week before saying I was not really an actor or a lawyer. But I have education degrees that make me both. In 2014 I filled charges against Shonda RHIMES company and they dropped those charges on Statue of Limitations. Within 24 hours I was attacked online over and over and it continued for 5 years. This person threatened my life. I filled charges with the FBI and they did nothing. I now suspect CASSANDRA may be the person who attacked me. They want me to shut up about GILBREATHE demanding I not only not talk about it online but that I never send an email out about it either. They are policing my life like I was the one who victimized GILBREATHE when I woke up with his hand down my pants. Recently she called me a criminal. I am just a girl who liked to pretend to be other people and liked to use my imagination. My imagination is my best friend. It is not insanity. I am just an artistic kind of person.

I want you to know I never attacked anyone. I never seduced anyone. I do not have any STDS. I am tired of the hypocrisy. I was a fan of your husband and not AFFLECK OR DAMON. But I had my own goals and dreams and when it came to relationships I needed friendships more than I needed lovers or dates. I have not been on a date since 2006 and I needed to make my own money. For some reason people did not get that without the industry I had nothing to work for or a dream to pursue. Money does not drive me to work hard. I needed passion for my work. My imagination is my best friend and the trolling and bullying has made me reclusive and I barely leave my apartment. Now I find that people say I am aggressive and will never be able to sue. I am being pushed to suicide. I am not going to have kids. I am never going to want a relationship now especially if it is based on a need to survive. I do not want to survive isolated and alone. I do not want to live if I am forced to be with people who are GOP or CHRISTIAN NATIONALS. I once heard your husband say the reason he did film was to leave something behind when he dies. Someone is stopping me from creating and being an actor and artist. If I am not allowed to be an actor I have no reason to feel like my life has meaning. Other people cannot force me to have a purpose I do not want.

I have lots of documentation on all of this including videos, and emails. I am so tired of fake news and the fact that a small group of people have managed to ruin my reputation on an international scale while I am trapped in a tiny apartment in Hollywood with no way to get work I would love. I told Cassandra her actions could push me to suicide and her attitude is that would be my fault to. There is something really wrong with the people doing this to me.

I attended an online workshop with Grant Heslov. I wrote your husband a letter at SONY STUDIO. I also wrote to Heslov. The letters were both sent back unopened. But the letter to George Clooney came back opened. In the letter I talk about some of the stuff in this letter. Within a week I was trolled by a fan of Carrie Finklea, who now goes by Carrie Finn, telling me that I should have made it by now and that she was a fan of Carrie. She insinuated that Carrie was not on twitter because of people like me. I did not know Carrie before 2015 and I blocked her accounts and never wanted to talk to her after she lied about me in 2017.

I have filled charges this past year with the STATE bar against the lawyers of SAG AFTRA and also sent documentation to RONAN FARROW because what has been happening to me feels like Black Cube from his book "Catch And Kill."

P.S. I read The Lost Girl. You are an incredible person. I want you to know my story because America is a dystopia. I earned SAG AFTRA. I should have the right to keep trying to be an actor. I am a woman who wanted a career and was never some celebrity chaser. I did my job on set. I wanted to have a good reputation on sets to move up to being an actor. I am never going to have fun for the rest of my life if acting is not part of my life. I keep having MEN tell me to move on. My response to them is move on to be raped by you. I like doing acting. I do not want to be in a regular job or be trapped in a cubicle doing work that is not creative or that does not involved my imaginative side. I test as an INFP. I make a horrible lawyer. I do not like fighting. I want to go back to being at peace and enjoying being alive. That is not going to happen if I am not allowed to be an artistic creative person. I have trouble sleeping. I am miserable and stressed and it all just seems to me to be like am being punished without a trial and lied about.
