Laura,

I never told you ABC contacted me to say what your trying to say I said. Instead I told you when you came into the office last week crying that I was told by my production team that you are not welcomed back on Grey's due to a situation that happened on the set. I do not know all the details, but when I am told by production not to have various talent back, I do not argue as they pay my bills. You specifically told me that you thought ABC and others were out to get you. Yes I did say that production was told by ABC that they did not want you on the lot, but there is no "watch list" that I know of and again this is something that I have no knowledge of and do not appreciate you trying to put words into my mouth.

Jeff Olan Casting is an Independent casting company and we do not dictate who is allowed on production studio lots or make the rules of who works in town, but we do have the authority to work who we think are the most professional when placing people on our sets, the vary sets that pay us. I took a half hour out of my day last week to sit and talk with you as once again you were shaking and upset about situations that have nothing to do with me or my agency. I am asking you know and will share this email with my staff for proof **TO NOT CONTACT US anymore with any problems or situations you are having with Central or other agencies, with actors you met at bars or dated, or with situations in your life that have NOTHING to do with us.** You did work some 68 jobs for us with out a problem until a situation happened on the Set of Grey's Anatomy. You even told me you were talking about things to perhaps the wrong people. We cannot baby sit everyone we put on the set so whatever happens there is out of our control.

We wish you the best in the future and are sorry that you are going through so much heartache with the entertainment business, but we can only do so much. I also told you the day you came in that we do not have a lot of work due to the SAG-Defacto strike and we are not placing that many people on our sets.

You have sent us numerous notes and each one of them have been you complaining about the lack of work and problems that are going on in your life. You have told me your father actualy put you on a Watch List and he works for Homeland Security so you cannot blame us for what is happening in your own life and the relationships you have with others. We just simply do not have time to trouble shoot every letter we get beyond what we have already done. We do not have to explain in deatail what is going on as we are an agency that works for various productions and when we place talent on sets you are an Independent contractor liable for your own actions.

Clarification please. You told me that ABC told you I tried to get onto a lot where I was not supposed to be. The day this happened, security told me that I was on a watcher list. You tell me I tried to get on the lot when I was not supposed to be there, but you booked me for that day. Arnie Store told me the day before he was booked and then I got booked. Which is true???

A friend of mine has gotten me in touch with an attorney with the Attorney General's office to see if he can refer me to someone. I want my file from Central. And it is not too late for that. You said I worked on 75 shows for you, no bad comments. I am still that same girl. I have had bill paxton hit on me, as it turns out he may have been separated from his wife at the time, but that does not matter. I stopped working his show. I had Henry Labonte talking to me a year after Sleeper Cell, and he talked to me like he knew me already which makes me think that Blake talked. I am a nice girl. Edgy due to having very unnice men in my life, but i don't need a man with money in my life.

I am a smart girl and I will go SAG and I will be working. And if I find out that what you said is what is going around and you and I both know that is a lie. YOU booked me that day. I would not cause a problem during a shoot. You are probably right. Someone did take the whole Blake thing out of proportion, but don't regulate it to me being a fan, because even one of Nick Stahl's stand ins at the time told me he wanted me. I am a good girl. And I was not ready for anyone in my life. I am getting my self together, but I will do what I have to. DON't push me back into background or think that it is OK to say I did something I did not, or would not do. That is detrimental to my reputation, and though you were obviously lied to perhaps. I know the truth, and you know me well enough to know that I may be emotionally unstable now, but if I were so crazy, I would have specd shows by now, and I don't do that. 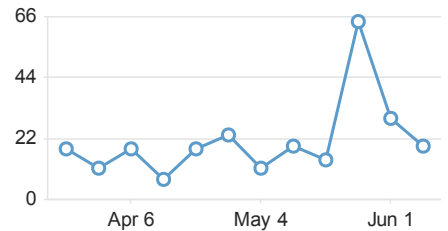

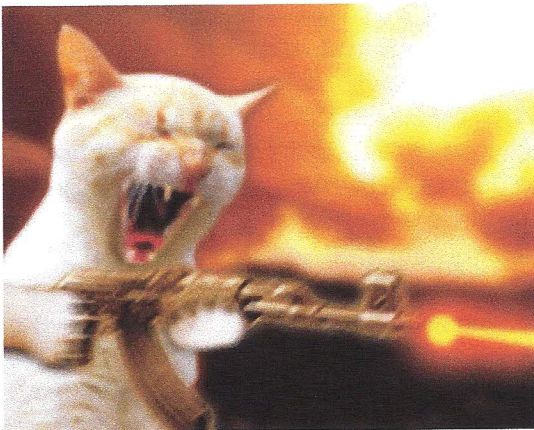

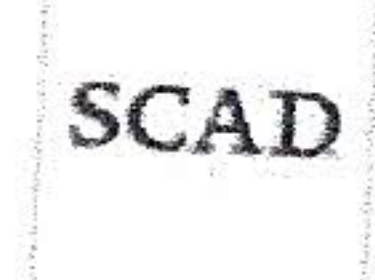
