I am not sure you will remember me. I was a Carni wife on Carnivale. I went on to work on other sets and beat breast cancer. I did not recognize you on Bones at first. You are a good actress.

I was working full time on sets in 2007 and a regular on a show called Eli Stone. they liked me there. I was training to do Photo Shop and Digital media as well. I got yanked off the show after complaining because the background kept inferring I was there because I liked the lead, but he had a girlfriend. IN January of 2008, I got tripped on set and was hospitalized, JT from Carnivale was there.

At the time this all happened I was being harassed by Jeremy Gilbreathe, Nick Stahl's stand in. I was also getting sick from gluten Intolerance. I confront the woman who told Central to pull me off Eli Stone when I told her, and this was my mistake, that if I was not going to follow an actor Like Blake Shields around who did ask me to go to drinks, why would I be interested in someone with a girlfriend who is not paying me attention? I never went out with anyone who stared on any show. At the time I contacted Blake and told him I was not interested in him and that Jeremy was assaulting me.

I keep working, though at this Point Central has told me I can never work for them again. I ran into Jeremy outside and audition in Pasadena only to have him say in passing that I was supposed to be fired and gone.

I go through physical therapy- the accident made it so I could not bend my legs for a week. I have worked on the set of Grey's Anatomy since August of 2005- two weeks after my mastectomy. ON set someone shows up from eli stone and Patrick Dempsey comments that no one would believe she is a lawyer, and then Eric Dane looks at me and says "she thinks she is an actress now." I was just in the PSA for Stand UP 2 Cancer and I made a little film called the Monster for their competition. two background artist make a comment that they know this couple that met in Europe and I say it sounds like they met their soul mates. I say I met my soulmate once but he was taken (it was an actor I studied acting with in college). Patrick Dempsey and Dane say "it must have been him all along." I show up the next day to be told by some stranger I am on a watcher list and that I can never work for ABC again. Cynthia YoungBlood, who I was told is Johnny Ponzio's ex girlfriend was working as a stand in and kept trying to get me into trouble. THIS WAS just a week before the thrid year anniversary of my mastectomy. I did nothing wrong.

now Jeremy gilbreathe is friends with all the casting people who used to respect and hire me. I have been told that people are saying i need "help" and if that is why I am not on sets when people knew that being on sets is what helped me survive the cancer? They tortured me. They had me recalled to tell me I was on this list. They might as well have told me my life was over and I can never ever be on a set again, while Jeremy who assaulted me gets to keep working.

The irony- Jeremy is obsessed with being famous. I am in a webisode that is going viral and for some reason I now have over 175 likes on my facebook page and climbing.

I do not ask men out, they ask me out. And I was working so hard on sets and in school and when I was told I could never be on a set again- they might as well have told me I made a mistake fighting the breast cancer, let alone being slandered by jeremy and his friends telling me I need some kind of "help."
