I am in LOS ANGELES fighting sag aftra and DISNEY. I have had a lawyer tell me they were terrified their clients would be blacklisted to.

I have an incurable autoimmune disease Hashimoto's, which is now progressed to severe Hypothyroidism, though I am underweight. I also have a yeast meat & latex allergy.

Lisa Joy and I shared an apartment in college my senior year along with her then boy friend. That was 1992. I moved from Westminster to Washington DC to pursue a masters in PERFORMING ARTS MANAGEMENT. After that I went to CATHOLIC LAW and received a Juris Doctorate. I moved to LOS ANGELES in 2002. Lisa knew I was dating a man by the name of FRANK KOH in 2002 but we were having problems. He had cheated on me and was possessive. For ten years he stalked me by phone and email in California.

In 2012 I was put into an institution by my UNION SAG AFTRA because someone said I would get a gun and they did not believe I went to law school. Now Lisa if she paid attention could tell you I hated GUNS. I actually played cop on TV sets in LOS ANGELES. But I did not want to own a gun ever and did not like the NRA. My parents are GOP and PROTESTANT and I hated them and their church in college. I was always a DEMOCRAT. I avoided spending time with my parents in college. I was a Maryland Distinguished SCHOLAR and phi beta kappa. I was a THEATER MAJOR and spent more time in college at the THEATER acting and working on projects than any where else on my college campus.

IN 2005 I lost my breasts in cancer. LISA KNEW THAT. In 2006 I was molested by JEREMY GILBREATHE. He did what STEVE MISSAR DID TO ME WHEN I WAS ASLEEP and I rejected him. Gilbreathe never kissed me. We were not intimate. I just woke up with his fingers pushing up into my vagina. His wife is a sorority girl from MCDANIEL COLLEGE. In 2008 I was tripped on a set probably on purpose. Both my legs were knocked out from under me. Next I am fired from every casting agency in HOLLY WOOD and every time it is DISNEY. LISA IS FRIENDS WITH JENNIFER DISNEY. I have often wondered if she is related to the DISNEYS. I join AFTRA in 2010 and I am abused by the staff. I was assaulted and a staff said the F word to my face. I join SAG and I have been a member of SAG AFTRA since 2011. But since 2013 the UNION had not let me attend classes or events. I have been going to events invited by productions. I had spent years networking and building a career. I trained in script writing and film making and digital art. I am PHI BETA KAPPA and MENSA. I Did not do anything wrong on a set. I have not been employed since 2010 because I was labelled delusional and crazy for saying I am a lawyer. BUT I AM. I resigned from the California BAR in 2012, bar number 20760 but I did go to law school and I did train to be an actor. I am BOTH.

I do not want a job with health benefits. I DO NOT WANT TO MOVE BACK TO MARYLAND EVER. I do not want to date men from MARYLAND. I am not GAY but I also am not interested in being in a relationship. I wanted an acting career. I am going to hate people back in MARYLAND for not standing up to me and letting a coke head who tried to rape me win.

I want to make sure LISA HAS NOTHING TO DO WITH WHAT HAPPENED TO ME IN LOS ANGELES. If she did she is liable for helping to mentally abuse me and helping to protect a guy who tried to RAPE ME. I called her up for help and she screamed at me she was going to call the police. I do not know why and was shocked by her response.

I test as being an INFP. THE first amendment means everything to me. I need ACTING FOR MY SELF WORTH AND MY AUTOTOMY. Someone is emailing me using the address cassandrator1980@hotmail.com telling me I am not talent and they want me institutionalized for the rest of my life. They are also telling me no one will ever hire me to be an actor. Well the only reason I care about being hired is if it is as an actor. I will hate any other job. I will not feel successful if I can say I am an actor. I quit law. I DO NOT CARE ABOUT BEING A PAID LAWYER. I EARNED SAG AFTRA, and I will not work in law to be paid to fight for others rights if I have no right to be hired as an actor.

I would rather leave the country if I can not be an actor here. I do not want to live in NEW YORK or move back to DC. I do not want to date a guy who wears a suit and works in an office. I have an incurable auto immune disease and a yeast allergy. I am also VEGAN. I never ever want to be a resident of MARYLAND AGAIN. NO THERAPIST IS EVER GOING TO FIX MY BEHAVIOR IF THEY CONTINUE TO TRY TO MANIPULATE ME INTO NOT BEING A WORKING ACTOR. I will hate my job and feel like a failure without acting. I was happy and single in 2007 when this nightmare began.

If I can not work in the entertainment industry I have NO BUSINESS and NO CAREER and NO COMMUNITY THAT I FEEL SAFE BEING A PART OF. I do not want the AMERICAN DREAM. I wanted a child of my own too. That is not going to happen now. I do not want to be anyones step mother. When I die I want to leave acting projects i created behind. I was working hard writing theater articles and building a blog about the arts. ARTISTICHOPE.com is mine and is WOMENLOVEPEACE.com.

If I give up acting I will spend the rest of my life secretly miserable. I will never be happy and I will feel like the last kid picked in gym. I want to SUE SAG AFTRA AND DISNEY FOR A DECADE OF BLACKLISTING ME AND FOR THEIR FASCISM. If the mental health community wants to take acting away from me they will be pushing me to depression anger and suicide. I have no plans for a future where I give up wanting to be a sag aftra actor.
