Dear Mr. Clooney:

I wonder if you know who I am. I worked on sets with you three times. The first time was "Good Night, Good Luck." It turns out my boss on the east coast, who passed away, Alvin Snyder, edited the documentary for Murrow. I am including a letter from him. I am not writing you about a job, or about a script idea. I am writing you because I experienced something in the industry and I need people like you to know. I need you to know because I am a victim of METOO and you know people who may know the guy who molested me and also be a part of blacklisting me, maybe without knowing the real reasons behind it.

On August 25, 2008 I was told to come to set on a Monday morning at Prospect Studios and was told Disney put me on a watcher list. It was the same week they announced you were cast in "Up in the Air." Patrick Dempsey and Eric Dane had found out I went to law school and apparently no one believed the truth. I graduated from Catholic Law in 1998. However, I did not practice law. I worked for Court TV in law school and in News Media and did some legal Temp work. I moved to California in 2002. I worked on sets full time from 2003 to 2008 and I lost my breasts to Cancer in 2005. I was sexually assaulted by Jeremy Gilbreathe in 2006. I was tripped in early 2008 on the set of "THE GOODS" a Paramount film, but then Disney blacklisted me? I have been fighting for a decade for justice because acting was why I beat cancer.

I believe this is really about rumors that were not true and elitism by wealthy actors who think I have no right to be in the union because I was not BORN INTO IT and because I earned it by being a background artist. Also I am an educated feminist liberal. I do not have an STD. I did not date anyone underage. I did not even have sex until I was 23 and the youngest guy I have ever been with was 18 (Jordan Marks- now a lawyer for ANNAPURNA PICTURES) and he lied to me and told me he was 20. I have been celibate since 2006 wanting a guy who would be my best friend and my age, which means we are in the same generation X.

Will Wallace, Terrence Malick's step son was my acting teacher in 2003. I have video footage of studying with him. He is a lawyer from Texas. Jeremy Gilbreathe who molested me is also from Texas as is Nick Stahls. I believe you may know them from the THIN RED LINE. Though I have never seen the movie. He was abusive to a

student and a bit to me and knew I went to law school. I quit studying with him before going to work on sets. His student told me a problem had to go away because he was raising a family in 2008, ME. Jeremy got his girlfriend pregnant apparently at that time. I just wanted him to leave me alone. Professor Carrasco at Santa Monica College used the same word where I studied from 2007 until 2017.

I know this sounds crazy. But it is TRUE and no one cares because I am not a celebrity. I cannot walk away. I did nothing wrong. I did not deserve for years of my life trying to work to be in the industry to be completely erased and replaced with lies and rumors. Some stuck up narcissistic actors decided I was LYING about the truth and had me labeled Crazy when I was not. SAG even had the police put me in an institution in 2012 leaving a meeting, Crabtree Ireland had the cops restrain me as I was walking out peacefully. I spent three days in a hold and then they tried to send me bills to pay for the hold. I now believe JASON GEORGE is a part of this as he is from VIRGINIA beach where my father worked when I was a child. My parents are GOP and I am not. I spent 18 years with their narcissism and acting was my escape and my source of self worth. Jason George apparently wanted to be a lawyer in college and knew JUDGES in Virginia. My family was known in Virginia. I come from politicians. But I am the BLACK SHEEP secular Democrat. IN 2010 the Actors Fund told me to go to church to find a job. I told them that was wrong. My father is a retired government Special agent with Customs. My mother a drug dependency nurse.

There is so much more to this. I filed with the NLRB in 2014. It was rejected but within 24 hours I started being trolled on Twitter. Someone created over 100 accounts. I had a following and it was hurt by this. The first account was one @mikeysanchez It started attacking me at the same time I was arguing with one ARNE STARR who worked as an extra with me on sets. The language ARNE used to bully me in his emails is the same as the TWITTER ATTACKS. Arne worked with me on GREY's ANATOMY and on Bed Time Stories. The last shows where I was terminated from CENTRAL CATING WIHT NO EXPLANATION and JEFF OLAN. Arne at the time in emails said I was paranoid and no one was trying to get me fired. But then I was terminated from everyone. Recently he sent me nasty emails calling me a STALKER. Saying I was up to my old STALKER TRICKS. I am fiercely independent. ANYONE CALLING ME A STALKER is twisting the truth to destroy me. The troll attacked me for the last time in August of 2018 actually pointing out that it was ten years from the month I was told I was on a list by DISNEY at GREY's ANATOMY. I worked Grey's for three years as a nurse from 2005 to 2008, after my mastectomy.

I have thousands of screen shots of the attacks. They even attacked me about liking you as an actor. I am vegan so I was not out to date you. I took the work that I found on sets or was offered. But you are someone I admired and wanted to work with because of your politics. I did say "I love Clooney." I care about the people I admire. The troll

called me a "WASP," a pedophile, said I did not get a scholarship to USC (I never applied there), threatened to slash my face and rape me, but law enforcement would do nothing. I still do not know who was doing it. At one point they said "do not fuck with SHONDALAND." Shonda Rhimes production company. I have not been a protestant since I was 18. They said my grandfather would be ashamed of me and knew I was GOP. My grandfather and family are. I have never voted RED and never would take the red pill. Who my parents were when I was kid have no bearing on who I am as an adult and at 17 I registered as a DEMOCRAT in Maryland.

In 2016 I was working on a film certificate and a certificate in digital media at Santa Monica College. I had started in 2007. I kind of went the wrong direction with my studies which is why it took so long. I had one class to finish the film certificate. But every time I signed up for the class, the troll would get vicious. I started to think a girl named CARRIE FINKELA who was in the class every time I signed up for the class knew the troll. In fact the troll one day told me I did not have white privilege and we had just talked about it in class. It turns out that FINKLEA worked with the director of "GOOD WILL HUNTING" and knows a girl named LILI BORDAN who is in a movie with Blake Shields. Blake knows JEREMY GILBREATHE who molested me in 2006. He also wrote a play in 2013 called DOUBLE BIND and used my name and the name of two of my ex boyfriends about a woman holding on to her husband. I would not do that. I am a feminist. I wanted a child and a career and my parents out of my life. I lost everything when I was stopped from working on sets. I recently found out in 2016 the head of the FILM department at SANTA MONICA College Carrasco worked on a short that Carrie directed with an actress from FLASH FORWARD that starred people I know from sets and also the lead of Flash Forward knew Blake Shields. I got a letter in 2017 when I came to class at Santa Monica College to leave CARRIE alone and when I got up to say the letter was a lie, they used the POLICE to run me off the campus. But I had written Carrasco in 2016 I did not want to work with CARRIE Finklea. She had yelled at me for nothing when she was producing a student film I was working crew on. I even told her to her face. I was NEVER STALKING ANYONE. I wanted an acting career and to network to achieve that goal but I do not stalk. I was an HONOR STUDENT with a GPA of 3.6. A year later they sent me the digital media certificate but I wanted to finish the FILM classes. Carrasco also said it is sometimes a woman's fault if she is assaulted while standing in front of me knowing I was a victim. Ellen Pompeo of Grey's Anatomy said the same thing about the Weinstein victims in 2018.

The lawyers at sag aftra say I am a member but have "BAD BEHAVIOR" and I am banned from events. They have been banning me since 2012 without any indication of when the ban will be lifted. They are going to kill me before I give up the membership or do get a real job and move on from wanting my reputation as being good on a set and good at acting back. I was told by a black man from Virginia at an event SAG AFTRA

wants IVY LEAGUE people. REALLY? So they want ROYALTY in a country that is supposed to be a DEMOCRACY? I EARNED SAG AFTRA. It is wrong that they have not given me due process and JEREMY GILBREATH who molested me is DIRECTING and his wife is a GOP republican. I do not cheat. I do not lie. I do not play games with people. But I am an actor and I am sick of people calling me crazy when I am NOT. My parents are. Ned Vaughn who ran the meeting in 2012 where they put me in an institution is GOP. Assaf Cohen knows the lead of a film I did called "Chemical 13." He said he is friends with Blake Shields. I told him in 2011 I liked actors. He indicated I should be dating men not in the industry. I think I am old enough to decide what I want and my being single and a woman is no reason to be restricting my access to the UNION or its benefits.

I filled with the state of California in 2018 2019. They dragged their feet and tossed it all, but before I got the letters saying they threw out my case, I was attacked by one Alex SOLOWITZ on Twitter. Actually he criticized my wanting Trump impeached the first time. Publicly he acted nice while Direct Messages were sent by him saying I was crazy. He indicated he did not know who I was. Over the pandemic I binged watched NCIS and found that SOLOWITZ who is Jewish and may have an addiction problem, worked in the same episode with BLAKE SHIELDS and they both live in VENICE BEACH. He called me crazy and said no one was talking about me, as in Celebrities. I think he knew who I was and was gas lighting me for Shields, Eric Dane or Jeremy. Dane apparently said I was "weird." I got emails from one ARNE STARR in 2016 confirming that opinion by him. DO YOU SEE THE PATTERN? I file with the government. The cast gets dropped. I get trolled on Twitter within 24 hours.

FYI I met BEN AFFLECK practicing BUDDHISM. He gave me a hug. Shortly after that he ended up in rehab and dating SHAUNA SEXTON. My mother's maiden name is SEXTON. I am not an opportunist. I am a practicing secular Buddhist. I told Affleck I had worked on sets with you because I have only seen a few films with him. I did not even see ARGO until after I met him. I am the SAME AGE as AFFLECK and MATT DAMON. I tried to tell DAMON at an event years ago I was blacklisted and he indicated I had a big head. First ugly laws are forbidden by the ADA. The industry cannot blacklist someone because they think they are UGLY. If he was talking about BRAINS. I am MENSA and once had an interview at YALE DRAMA for Theater Admin. I am not your average person. BUT I am also not a stuck up who thinks I have the right to look down on someone else and I do not think that DAMON has the right to insinuate I am stuck up when I had never talked to him before telling him I was blacklisted at a q&a in Hollywood. I have been fighting since 2012 to get the UNION to let me have my rights back and to have the acting career I wanted but apparently even though I have a theater degree, trained to cold read, and have four SAG VOUCHERS I am not worthy of SAG AFTRA? There is some secret hand shake or genetics that would make me good

enough. I feel like I am back to being the smart kid in school that gets picked last in gym and the actors at the top are all a bunch of bullies. I want what I EARNED. I have ten years of being denied the rights I EARNED as SAG AFTRA denied on LIES.

FYI I was with the SAG FOUNDATION until 2013 when I asked KATE WALSH who has worked for SHONDA RHIMES why I was blacklisted at Grey's She put her finger to her lips like I should be quiet. Next day I find out I am out of the SAG FOUNDATION data base and get a letter telling me not to embarrass myself again by coming to their events. I am phi beta kappa theater honor student with a MASTERS in PERFORMING ARTS MANAGEMENT. I trained to do TV And FILM acting at AMERICAN UNIVERSITY.

I am including an email between me and a friend of JEREMY GILBREATHE. His friend says his COCAINE addiction made him molest me. Ask your wife if that is a valid excuse. JEREMY GILBREATHE worked with BEN AFFLECK on his first film and also worked with KEVIN SMITH in 2019 both as CREW and ACTOR. I get offered an extra job for the first time in ten years on MANK. It was at the time I had filled with the STATE in 2019. I said NO. I had been tripped on a set in 2008. JEREMY GILBREATHE had worked crew on SOCIAL NETWORK with the DIRECTOR OF MANK. I was insulted. I had gotten some acting gigs and Did not want to go back to being an extra. After all to SAG AFTRA that is all most of us are and that is NOT RIGHT. I AM in debt from LAW SCHOOL. I wanted healthy relationships in my life and a HEALTHY career in the industry. I want JEREMY GILBREATHE OFF SETS FOR A DECADE like I have been. I WANT JUSTICE for the all the work I did to earn SAG AFTRA only to be SPIT ON WHEN I WAS SICK AND RECOVERING FROM Cancer. I now have an autoimmune disease. I got cancer only for it to trigger an incurable illness that I have to struggle with while being TROLLED AND ABUSED OVER and over to the point I was terrified to leave my apartment.

I am a little like JENNIFER GARNER. I was raised Methodist by SOUTHERN parents. I studied O'Neill and THEATER in college. But I rejected my family and their religion and became a YANK a Catholic and I love JFK and MLK and voted for OBAMA. I am so angry at the religious in this country for giving us TRUMP for Potus and I beat cancer to be an actor so I kind of rejected GOD. I support FFRF and am for the UNITED NATIONS BILL OF RIGHTS. I also believe in PROFESSIONAL standards for Journalists.
