Guess what ARNE- I am still here. I have spent the last 4 years, just as I told you, wishing I had died of the cancer. I printed out all the wonderful emails between you and I from 4 years ago before I closed my old account.

How dare you? I was no threat to anyone. I heard you on the set of Bed Times Story talking to the young woman I had been sitting next to about me hating on her religion? Was that scientology? I find it interesting that you are on NCIS Los Angeles when the lead of that show used to be on Grey's and his lawyer is the same as JOHNNY LEE MILLER.

UNDER THE CIVIL CODE OF CALI- It is illegal to blacklist someone for religions race sex, and they also include mental or physical disability. Grey's did this to me 3 years after I had my mastectomy. I was suffering from probably PTSD from that trauma let alone finding out two people I knew had died of cancer. I ended up getting skin cancer and I have neuropathy in one of my feet that comes and goes and can not afford to get tested to see if my cancer is back.

Calling me paranoid is the same as calling me crazy which is creating a hostile work environment for me. I PASSED THE TEST TO WORK FOR THE US CENSUS and worked for them until they laid me off for lack of work. I AM WHO I SAY I AM. Look me up on IMDB. I AM A RETIRED LAWYER. I WILL NOT WORK UNLESS I KNOW I HAVE A FUTURE WORKING ON SETS.

I was banned from sets, according to JEFF OLAN. I was banned while a man who assaulted me still gets to work and for DISNEY. I sent a letter I wrote to him to leave me alone to the FBI in DC. I happen to know the son of the senator of HAWAII. LOS ANGELES is not just where i came to work - IT IS MY HOME. ANd taking away what made me want to survive when I had cancer was mental cruelty.

WHAT DID JAMES PICKENS mean that last day that you had nothing to worry about? YOu walked up to me on set that day to tell me you were recalled and I told you so was I but that you should not be on the phone on sets. The look on your face was one who expected to HURT ME. HOw sick is that with everything I have been through. You knew i had a mastectomy. I mean was me getting fitted on STAR trek, which i kind of would like to know how you knew about before i told you, that harmful to you, because as you know I could not work it because of my allergy. YOu saw me in the PSA for stand up 2 Cancer- hello I had cancer. I am also a trained actress. You could not even look me in the face about it. I can do photoshop but then you keep sticking your nose up at me about that too.

I had everything I was working for ruined by the actions of the actors on Grey's and ABC shows. I was using background for more than just sitting around and you and even crew from eli Stone knew that. I have a letter from a crew member of that show as a reference about how I studied production stuff while I was not working and how hard working I am and was.

I find it interesting in fact that the AD of Eli Stone- told me I was still on his list while Casting told me that the PA told them I was off, a PA who was friends with Marquessa Moreland. I have also heard the rumors- that i am "difficult to deal with." Same as perhaps the phrase "problem source." If I am difficult to deal with WHY DO I HAVE A BOX FULL OF PAY CHECKS AND I SPECED 3 times in 5 years.

I AM FILING CHARGES AGAINST PATRICKE DEMPSEY AND ERIC DANE for the comments they made the last day I was on GREY's claiming I was not a lawyer, that i was not an actress, and I heard them say that they were going to tell security that someone was dangerous. I show up the next day and I am told I am on a WATCHER LIST. Do you know that cali protects even people with mental disabilities and I worked GREY's two weeks after my Mastectomy for the first time in September 2005 and the last day was August 2008 just before the anniversary of my mastectomy- you sick bastards. I see the scars and I am reminded that I had the only reason I survived that hell stripped away by a bunch of horrible fame obsessed twats, including you.

I am representing myself here, and you should know that telling people I am against their religion is not ME spreading the hate- it is you making me look like the bigot and the hater and thus causing me to be prejudiced against.

SLANDERING ME ON SETS STILL after 4 years is a sign of OBSESSION. Thank you though- because it means i have a continual harm and can SUE still.
