Why are you Actors Fundsending these to me when accordibg to sag aftra im not allowed in the building? Do you provide lawyers for actors? I need one pro bono or contingency. I want to know if you offer legal services because i want to sue Sag Aftra for defamation, discrimination, unlawful use of the legal process, intentional infliction of emotional distress.

I vote in the sag awards. I am not Ficore. The union is denying me the training and education with potential employers and effectively preventing me from my careers goal. .and Jason George i lived in Virginia Beach until i was 5 and you and i would have been in high school together. In 2003 if you had dated a 19 year old would you be shunned? If im too old to be an actor so are you. Otherwise you and the union are sexist.

David Lawrence asked me out. I have a copy of an email asking me to call him. I did not ask him. Blake Shields and i never dated but we worked together. Ive never been the type to throw myself at men or to stalk ever. It is shameful to me that the union and the industry has turned my feelings into some kind of crime.

There security guard grabbed my arm. To make him let go i flashed him. Yeah i took off my shirt as an action of self defense. If you do not physically attack me i wont do something like that. Nudity is not a crime in california unless of a sexual nature, and can be construed as an act of self defens. I already showed him i had a file folder of paper and an empty bag on me.

Same security guard stopped me entering a meeting this past year after i was checked in. I have a right even if my opinion may be different then republicans with the union to have a voice and politically participate. My getting emotional? You do not have the right to tell me i have to agree to everything the union does and slence my voice because it is unattractive in a woman. Same man. I was told they called the police on me. I walked out peacefully and walked from the lodge to trader joes and caught a bus home. Not once did i see the police and i called a woman with the smart police and told her the union has to stop doing this to me.

Assaf Cohen told me that he thought Blake was hard working. That was my reputation. I told Asaf that in 2011, than he started acting like i was anti merger, even shouting "she is assaulting me" when i walked up to him with my arms full. I pointed out to him i couldnt assault him. I want justice. Do you have a restraining order against me because the police know where i live but i have never received a document and their is no record of a court case?

Ive never assaulted anyone affiliated with sag aftra by the legal definition. I have hashimoto's. I am an actor. See attached news article from my college graduation. I spoke out against the merger. California has an anti SLAPP law. Blacklisting is also civilly actionable. I want restitution for mental abuse Ilyanna. Youve known since 2013 Kristi Funk was my breast Cancer doctor. Ilyanna the VP of Sag Aftra once tried to push Ed Harris away from me, but he turned around and shook my hand. Why? Because i look like a Wasp to you? That was at an AFI event. My bar number is 207690. Im also trained to edit. Because i am a poor but intelligent woman

im crazy. You can not fathom a girl like me being capable. I have pages and pages of twitter attacks by someone who claims they know Rain Wilson hangs out with Patrick Dempsey, and that i should kill myself and that the union says i am not allowed to socialize with you because i lost my breasts. This person says im republican and that the union can exclude me on religious grounds. Ive known Blake Shields real last name was Abramovitz since 2006. I didnt go and become a jew. The person on line attacking me has used words lie chakras and called me diablo blanco. They also claim i consented to Jeremy Gilbreathe finger fucking me.

I do not want a future if i can not have acting in my life and what the union is doing is protecting men who used me to feed their ego and cut me down because i am educated.

Please note Assaf & Blake both spent time in Israel. I am not jewish. I am zen buddhist. If i were a stalker Assaf i would be at tenple probably in Venice or Santa Monica. Ive practiced passover as i had jewish friends on the east coast and i am for Sanders for President. I was a member of the Santa Monica Catholic church from 2003 to 2007. I used to live in Culver City. I consider Santa Monica my second home regardless of where Blake Shields is.

Im trained in photography & editing and worked on all these productions where Marc Geschwind was also employed.

I made 20000 a year for 5 years on sets at 54/8. That is allot of time & experience on film and tv sets and im also a trained actor. This is wrong. Labelling me as mental because i spoke out about the union and Assaf discovered i was not obsessed with Blake Shields. I want a man in my life who respects acting and the craft. Not someone who would go along with excluding me like im a freak because im not a jew. Look up Blake Shields and double bind. To me the real double bind is women being told they have to get married and have to give up their careers to be housewives while expected to feel successful. I want to be an actor. I will not date lawyers or crew. Im not here to be taken care of and frankly from my dating experience a guys idea of loving me is money and making me sit at home waiting, not letting me achieve things i can be proud of. I want to fight for a career. I am not a scientologist. And you do not have the right to make me.

I also recorded phone calls with the police. I suspect who ever contacted the cops on me knows my twitter stalker.

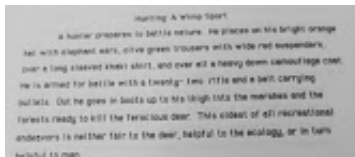
