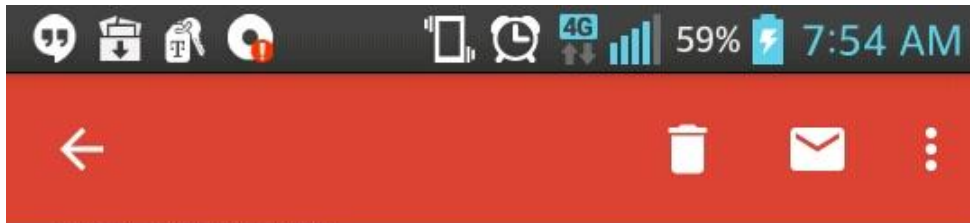
We met at the candidate meeting. I am very emotional about stuff that happened. I am also tired of being harrassed. I have worked my entire life until 8 months after I was tripped in January of 2008. I love working on sets and it got me through cancer. now I can not feel three of my toes. I have had cancer twice. I am scared. And the fear is making what I lost even more terrifying. I went from working on over 200 productions to none over night and then I run into people I worked with all the time who ask me if I am working and remember how much I worked and just loved being on sets.

I was not dating anyone. Not interested in dating anyone. I wanted to get my life together and I was studying digital media. I was a licensed attorney here in California but I recently retired. I do not care about getting work in that field. I do not love the industry. What happened to me- stopped everything I



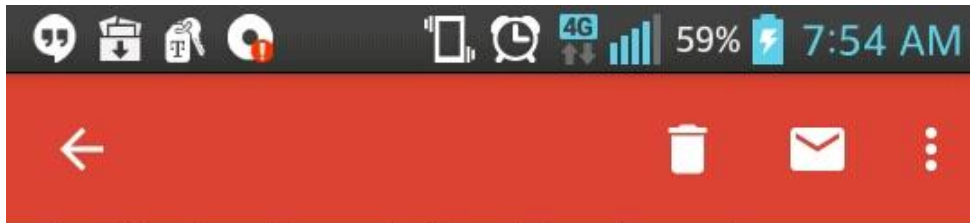
I was not dating anyone. Not interested in dating anyone. I wanted to get my life together and I was studying digital media. I was a licensed attorney here in California but I recently retired. I do not care about getting work in that field. I do not love it. I love the industry. What happened to me- stopped everything I was working for. I did not hurt anyone. I did not harm anyone. I did not cause a production money. I did not hold up a shoot. I did not talk to principals even unless the spoke to me first and chose to friend me.

It is completely frightening and when people in my community comment about calling security and I passed a background check to work for the Census and I know the son of the Senator of Hawaii. I've known him since 1993. He knew I wanted to fight to act. I feel as though I was expected to go get a real job, get married and have some kids. I can not do any of that unless I am acting and know I can be on sets again. People in the industry at the time knew I had the cancer. And this happened just three years after I had the mastectomy. I need to know who the man was who told me I was on a list and why? I know what I heard that day. But this whole mess is insane-like something out of 1984 novel. I know people who heard about it have told me they think what Gray's did was horrid. I guess they heard about it on set. I have an email telling me I can not be on ABC sets again because of an incident but there was no incident. I did nothing wrong. I certainly am not dangerous-unless you count being a buddhist and practicing honesty and a strong determination to be a working actor and not being forced to go work in a profession I really do not like.

New Development- Will Wallace. I watched him bully a student out of class back in 2003. He convinced me to leave AFI by insinuating that the VP there was cheating on his wife to study privately with him. He abused me eventually as well so I stopped studying with him right before I started working on sets. I went to a play once with a student of his at a theater and Noah Wyley was on the board of that theater. 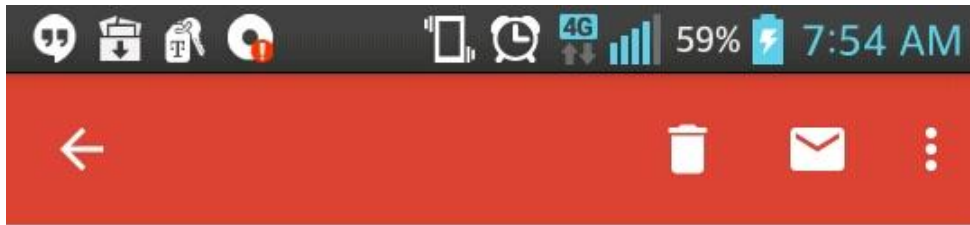
I am sick of being treated by people with union cards like I am a terrorist when I am an actress and their equal. In addition, a student, Nicole West, of Will Wallace threatened me, or she basically said that someone needed to be gone because will wallace was starting a family. I was also assaulted by a guy named jeremy gilbreate who worked on Carnivale as Nick Stahl's stand in and Nick Stahls starred in the Thin red line with Will Wallace and I was tripped in 2008 before I was told I was on some list and a guy named Jt who was union was on that set when it happened and it was not an accident. I was told to run all out or I would be fired and with in an hour I was in the hospital. I took a class at AFI and the teacher Jentzen kept going on about how Will Wallace was



her friend and how she loved America and everyone who knows me I am buddhist and I believe very strongly America is a melting pot and I prefer Euro men and men who think beyond good old fashioned american pie. As a woman with rights I do not need to be abused for my tastes and preferences, and if anything that shows me that Will Wallace and his friends have been spying and effectively stalking me for years. jentzen was on my twitter account for awhile and my Myspace.

Will Wallace was at the Do Something Awards as crew or at least someone who looked like him walked by me in a cold stance and I actually called after him but he kept walking "will." that says they put me away from the camera but backstage Lynch took a picture with me and several other people who were playing her double. the man must know I had cancer because his student Nicole saw my scars. I showed her. I was also abused by a woman named Marquessa Moreland who worked with me on Eli Stone and seemed to have something against me. I was told a production co she was with or group may have been working out of the Complex but I do not know if that is true, where Will Wallace taught me.

I am a retired lawyer. But if Will Wallace has the right to work in the industry so do I, and legally there is no excuse for how I have been treated or bullied and as someone who when this happened, had good credit, was in school to study entertainment technology, had just beaten cancer three years before and was working full time on sets- the actions of certain Union members were unthinkable and totally unprofessional. I lost two years of my life and more



I am a retire lawyer. But if Will Wallace has the right to work in the industry so do I, and legally there is no excuse for how I have been treated or bullied and as someone who when this happened, had good credit, was in school to study entertainment technolgy, had just beaten cancer three years before and was working full time on sets- the actions of certain Union members were unthinkable and totally unprofessional. I lost two years of my life and more, every day I sat in a class striving to do not just acting, but production work. And if ABC prevents me from being on their sets, then they prevent me from working for all the networks. I went from making 20,000 a year to nothing and I have been repeactly abused by private security people at jobs I have at art organizations and even had the legal fed ex make a comment to me when i went to pick up a package- "oh we heard about you" and we called security. they gave me the package, but I am a girl who hates sharp objects and is against the NRA. I am a buddhist and I only want to work with artists and actors and film makers. Not be abused by want a be cops.

STATEMENT AND QUESTION FOR THOSE RUNNING- LAURA ANN TULL ↵

This may seem personal to some, but I could be any person fighting for a career, any woman looking to earn her own income and her own dreams. Three years ago though I was told I practically needed to find someone to date to continue to work. That was wrong. ↵

I want to know what you who are running are going to do to stop people who are UNIDN from abusing it to stop people like me from working to be a working actor. There are rules in California about creating a hostile environment- and what happened to me was an assault of my person and my career. I worked on over 200 productions, and I did it with pride. Fought breast cancer and there are background SAG people who have made fun of me and picked on me and that kind of behavior in any other profession in California would be unlawful. ↵

Eli Stone- keep in mind the Head of the EEO was an actor from this show who would not talk to me and AFTRA told me I could not do any acting, including in 99 seat theaters for a year, gave me my \$ back after I told them if they were not going to let me on their sets I wanted to resign. And they gave me all of my membership dues back. I wanted to talk to this man and ask him why I had the only reason I fought cancer taken away and he would not even look at me. He is from VA, the state I was born in, but not proud of. I responded to an email from family back there telling them I loved California and I was furious when my family inferred it was a state where women had fake boobs- I had to have a mastectomy. The email got sent to many people in politics back there and they were not happy with me. ↵

If you are running for office, can you look me in the eye, because I am equal to any of you? I am trained to act, and even if I did work background, how dare you have the position you are in, and not be willing to understand that any one on a set who is in the position of being in front of the camera, is also a potential actor and deserves respect as such. Background and extra should not be synonymous with this person is never an actor and never will be. ↵

I had a crew person tell Central to take me off the list for Eli Stone after I told her I was being bullied by people insinuating that I was interested in a guy who was taken, not the head of the EEO. The show kept the bullies. The background kept making comments about my figure and basically creating a very hostile environment for me. I was planning on just finishing up the season and being done with it. I do not hog the camera. I do what I am told. In addition the actor from the EEO also made a comment about how it was too bad someone did not look good on tape. This is coming from someone who is for equality. Background Casting takes any comments in the negative as though you are no longer cast able even if it is not your fault. This crew person later admitted to being friends with the person who was bullying me. I fought to keep a good record and I was proud of it. Again 200 different productions and that does not include commercials. ↵

I was later tripped on a set with crew from this show. Told to go somewhere I was not supposed to be by crew on a film set who work on ABC family sets and people who knew these individuals who bullied me. Then later told I was not allowed on another ABC show after this same crew person kept shushing at my table on set when it was the woman next to me who kept talking and the AD that day actually had picked me to stay. ↵

At the same time I was being assaulted by a guy who at one point sexually assaulted me. I wrote him a letter telling him to stop and that if it continued I would file a restraining order against him. This man

had been fired from a show for cocaine use and had a history of doing things like leaving set to sneak off with a girl, and he had a girlfriend who as it turns out went to my college years before I did. Small world. ↵

Recently this guy worked with actors from Eli Stone, and the girl who bullied me laughed as this guy made fun of me on a set. Later the show pointed her out and made a character of her. This same girl was featured in a film starring a friend from the EEO actor. If you do not know, by now I am talking about Jason George. So I have been sitting at home being and having been told I cannot be on ABC sets again, after I am tripped and have a worker's comp claim, the industry is still hiring the guy who assaulted me and to work with actors who I am led to believe are responsible for my work being taken who bullied me
