Thank you for talking to me yesterday but I made a promise to GOD that I would never do what other people want me to do with my life if it lead me away from acting. I know in my heart god made me to be an actress. I have the gift of a mimic, can sing, can memorize lines better than anyone, and I am proving that, and I can act. My only set back is I don't look like a model. I am sorry but if I can't make it in this town in my mind it has nothing to do with no talent, because I know I can act. I got into the AADA's summer program last year solely on an audition, and not on grades or recommendation. It is sad that because I will not join a cult and refuse to bow to Hubbard that certain groups have turned against me. Reality is I was raised to believe in the Constitution, and I can't go against what I know is right. Demanding anyone join a religion to pursue a career is a violation of my first amendment rights. It is also a violation of due process for ABC to basically prevent me from working without just cause. I am only interested in surviving if I am acting and working on sets and only if it is here. When people say "she thinks she still has what it takes to make it.... they are being animals becuase the day I believe I don't is the day I do kill myself. Because the only reason I chose to live is acting. There is nothing else in this life that gives me joy or hope. I can crochet, but I don't find it fun. I love watching movies and TV, but I'd rather be in them and make them, which is why I don't miss my TV. From my perspective I am being abused for my beliefs and for the fact that I will not sleep with actors..... that to me is kind of twisted.

Jonny Ponzio was supposed to help me with a documentary and he tells me to leave to act. I have seasonal depression. I have bad knees and I have a nasal condition and it is not safe for a single white female to go to South Africa or India or elsewhere right now. This is my home. AND frankly if you told me I could not be on sets anymore and had to leave, I would do what a background artist suggested- eat borax cause from my perspective my soul mate is some actor who at his age is probably established already, because I should have come here right after college. Fame is not what interest me, but good work and challenging parts. I walked away from a man who was worth 10 million but did not like acting. I actually dragged him to a class once, that one of the instructors is actually on my face book. The teacher criticized everyone but me. He simply asked me where was I trained. It was an acting class to help lawyers use acting skills. I already had the skills. If I leve LA I have a future with nothing but pain..... would you want to live if you knew that. As to my parents, my father is a gun collector and forgetful with age... sooner or later he would leave one of his guns out, and probably knowing him, on purpose, and I would shoot myself with it. Living a life where he controls who I know and who I associate with is hell because I would rather know people like my friend musicians. Funny thing is there are two guys here who I suspect are interested in me and to my knowledge both are single and one I am just getting to know and that is my business, but what I hate is how the gods of the industry think they know why I am here and what I am doing. Now that I have said that I am going to be paried up wth someone who I am really not interested in just because this town is a bunch of high school kids. Which may be part of my problem, many people in the industry do not have my education. I know I will me miserable for the rest of my life becuase some office job is not going to put me on a set where I can see George Clooney work and I would rather die now than spend the next few decades knowing that I only had 3 cool years in my entire life. Under the Constitution I have the right to be in CA even if no one here wants me. I know I would rather have died in 2005 if I have to leave. NO therapist is going to convicne me otherwise. My IQ is too high for most of them anyways.

I wanted to conduct 150 auditions, figuring I would get 1. I have gotten so far 2- a student film and a movie.

I did what you suggested and I called Disney. FUNny thing is they kept putting me into a John Lotts voice mail. I was transferred to their legal, supposedly, and got transferred again to John Lott. Looked him up---- no attorney. Yet Disney was inferring he was an attorney. They could not even tell me what his title was or what he did. In charge of "special projects" is all they would say. On IMDB the only John Lott are actors or FX people. Finally I demanded I be transferred to a lawyer. They put me to one Melinda Markenson?? I talked to her assistant and told her about the woman from Eli Stone. I said "for all I know John Lott is this woman's fiance and if so your company has just proven what I have been trying to say. This woman came after me, and her fiance is probably the one behind my being on a watcher list."

As to actors, I know some of the actors from Carnivale and I know one of the women from Deadwood. I was on

Grey's last season when Debra, the bearded lady from Carnival, was there and she talked to me. When i went to the Carnival fan convention I signed two autographs- which was weird, and the woman who started the save carnivale campaign is from my home town. I will not go back there though to a life of misery. I have no reason to want to. I am in contact with people, but I have no desire to see them. I have had enough pain, and most of it was there. This is home. This is where I belong and it is not GOd forcing me out. I will chose to die if I have to leave, and since I know at least one Casting agent at Central knows how I feel... who ever is doing this is committing murder. I will end up dead. I have nothing to live for if I can't make the money I need by acting. I have lost it. I am not insane because I want to work.... but on my terms and only my terms. OTherwise I have no reason to want to go on..... I am tired of pain. I am tired of being forced into loveless relationships just to please others, and I am sick of being controlled by others. My fahter to me is an evil man and I wuld hurt myslef if I had to go see him. Another promise I made God in fact. IF I ever did get involved with a man, he would have to sign a contract where by myfather would never be allowed near me or any kids we had. I hate the man, and i have told him so. I hate my family. They just want me to be the normal 9 to 5 person, and though I love to work... I can't do that. I prefer the crazy hours of the industry. I was also working on a one woman show that i actually heard background people say was not going to happen now. Funny thing is if someone here is worried about what I would write, making me mad is a sure way to make sure it happens...

I just hope that who ever has decided to kill me, never gets what they truly want in this life either. I have never had what I wanted, until I worked on sets. I have only had 3 years of joy, laced with pain. AND NO I DO NOT KNOW I DON'T HAVE WHAT IT TAKES TO MAKE IT>>>>>> I AM TOO SMART TO GIVE INTO BULLIES> BUT I DO PLAN TO DIE> I only wish I had taken my life in 2005 when GOd gave me what I now consider a gift. I could die without being called crazy.

If anyone goes to see Ray, tell him I think he is a great actor and I am glad I met him.. Anytime anyone sees NYPD Blue, he lives on.... . (Don't tell him this, but if there is an afterlife, I'll gladly buy him lunch.) I know that there are forces in this town trying to make me disappear. I even was told taht after a time they would erase my IMDB credits... That is why I live for acting..... I want to leave something behind and it is too late for kids..... As to men, men are in this world to make babies with, so why anyone is worried about who I sleep with now baffles me. Unless I can make a baby, which I am pretty sure I no longer can, I really don't need men other than as friends.

SAG may call you today. I called them and they are looking into this for me. If someone at ABC is trying to infer I am a danger, they are crazy. I had a masectomy in 2005. My doctor was the same doctor who worked on Pamela Des Barrer, the woman who wrote "Im in the band." I actually wore a shirt with that on it the day I went to see my doctor, not knowing anything about Ms. Des Barre. I actually talked to Ms Des Barre at the time. She called me to give me support.

I just talked to my accupuncturist who has worked with me for years. She knew me back when I came here and could not walk right. Despite the fact that the doctor for workers comp, who is being paid by the industry, says I am fine, she has told me I really should not run, and she saw my MRI from the accident in January. I am not the one committing fraud. ABC and Paramount are. They are taking away the only reason I want to live out of pety greed and all I want is my legs back the way they were before January. I could run if I had too, but would not run except on the eliptical at the gym, and even there I ran backwards for years. (Yes backwards.) I am a tough girl but this is crazy. I am physically not capable of hurting anyone and who ever is doing this to me is the real monster in all of this. I have no future unless I am in the industry. I don't want to do anything else with my life.

This is insane to me. And I can't go back east or move to London. That is what is really crazy about all of this. I do have bad knees and they do hurt when the weather changes. In fact I need to go back to my accupuncturist.

I had a perfect record with Central Casting too before this happened with Eli Stone. I was never late. Someone fabricated a lie. Back in December I told Mark Gerschwin I was on the show and I get pulled off within days. Two weeks before a crew guy gave me a hat from the show, a hat I still have. I worked it 29 days, and now I suspect that the new ADs are friends of Mark and that the girl in the attached fiancé and ABC have been pushing me to get fired all along.

LA is the only place I have ever truly considered home. I will never leave here, and unless the movies are being taped here, I will not work on them. So not being able to do TV has destroyed my life. When I had cancer the only thing I had was my job. I did not have a group to talk to. My job is why I chose to live, now I keep wanting to go back to 2005 and chose to die. No psychologist is going to change the fact that I did nothing wrong and lost the only job I ever loved and the only time in my life I ever really loved life, especially when I know I did nothing wrong..... NO lies. No deceit. Hell if I lost my job at all, it is because I would not sleep with anyone. I would not even let any of the actors on the show talk to me. This is sick to me Jeff. I know you have been in this industry a long time, but legally ABC has committed a fraud against me. But apparently that is OK. We don't have a Constitution anymore and I have joy of having people I don't even know make comments about how I was fired and how I should pack up and leave. Only if it is to be buried 6 feet under, and Janeta Houk knew how I felt... knew I would never want to leave... and knew my father hit me and that I could not live where it was cold and that I loved my job.....

Thanks. For telling people I was fired and that I don't have what it takes to make it. Someone sent me an invite to a premiere party for the movie the Doorman about a guy who thinks he knows people. When I had cancer, I only had one thing for.... my job. It is the only thing I loved, because frankly not having nipples, I could not love myself. I was proud of having a good record at Central. My dad can pay for my SAG card. But I wanted to do that on my own and take care of me. I wanted to do graphics on the side, but only if I could still work on set. I lost the only thing in life I cared about. I will end up killing myself one day, simply because I know I did nothing to lose my job. Central had to try to falsify a cancellation to get me into trouble. YOU said I have a future... well there is no future for me. I have not hope of not being in pain or being happy again and I made a promise to God I would never ever leave LA or quit working on sets. I've been reduced to working BG on adult films, and I hate it. Who ever told you at ABC I was gone and has systematically labelled me something that I am not.... I prided myself on the A. I can't hurt anyone. My physical therapist has told me I should never run. The only thing I want to do now is make money as an actress.... and if that makes me insane I guess I am. But I think the way ABC is treating me is crazy... I am not a monster. and I hope though that who ever decided to do this gets cancer so they know how I feel... so they know how much I now wish I had died in 2005. The day I can't support myself on set, is the day I will end up dead. I should not be treated like less than human or like I don't deserve to exist. ABC had no right to tell Central to fire me so I can;t work for CBS or NBC either. They are the sick ones and I hope that someone realizes and someone gets arrested for negligent homicide, because people like Mark Gerschwin and Janeta Houk knew how important my work meant to me. One movei may not cut it but I am a far better actress than I am anything else. I Heard you say I don't have what it takes.... reality I was not living for one show. I live in a bug infested apartment in LA, but I have classa and standards, but I will not bow to bullies and if I am gone from LA it will becasue I am dead. They have killed me and what makes me sick is I know they dont' care.... You tell the producers at ABC they took the only reason I want to live.... I have nothing to look forward to and no reason to want to eat or function..... I will not be miserable for the rest of my life and just live.... Someone committed a fraud against me..... Thanks for contributing to it.

You see my vision of my future- go SAG and work on sets. Save up for a camer. Act... Make pictures. Art. I am good at photoshop... really good.

Now i have lost the only thing I love in life. I probably want pass a background check, even though I never committed a crime. I don't sse a future Jeff. Never. I don't plan on doing the graphics now. I have post tramatic stress disorder. I will never be able to practice law, and unless I get bakc on sets, it is going to drive me insane being treated like a criminal when I did nothing wrong. This is sick. I am just living my life. I am in school too.... I can't leave LA. This is my home. I have every right to fight to be an actress. I have been aiming for that my entire life. I wanted to work as a lawyer to support my craft, only. In all seriousness if I had not had a car accident, I doubt I would have stayed a lawyer for more tahn a few years. Now I am in debt up to my head, and I would kill mysefl before practicing law. YOu say I am attractive. That is bull. If anything that is why the new ADs who I am sure are friend of Mark Gerschwin wanted me off. I jsut wanted to finish the season and move on. Of course I am a BG, so no one thought to ask me, they forgot I could talk..... I never talk to principals unless they talk to me, and frankly, I will never run again. I will never be happy again. I lost the only reason I wanted to beat the cancer. I lost by boobs. I lost my hope. I have no interest what so ever about working behind the scenes, if there is not hope of me being in front of the camera, so I have no reason for wanting to live.

I can't get help. My family is horrible. My father hit me and does not care what I want to do, only what he wants and only if it makes lots of money. This is not right at all. I can't practice law I cant. I did not do anything to deserve to lose my job. I am not going to get another job either. I am going to die. I want tooo... The only thing that made me feel like was worth something was being on sets. I am not anti social or psychotic or obsessive. I needed to have a purpose and a goal. I had one...ONE>... Only one. I did not want to rule Hollywood. I did not want to be a star. I just wanted to grow in little steps. build a career. I saw no man in my future. Just me getting a job as an artist, which I can do, but only if I could be on sets. This is not right. This woman whose picture I sent you, after telling me she hated the Pilot for Eli Stone and knows I work there, shows up there and makes my life a hell. She came after me for some reason. I see her on a PSA for cancer, and the AD is telling her how I won't be here when Eli STone starts taping. I am still here, but the only way I would not be is if i were dead. I have no intention of going anywhere else. This is my home. DAMM IT.... I can't survive the pain of going back east. I am sorry but I CANT RUN!!! I DO FEEL PAIN IN MY KNEES WHEN THE WEATHER CHANGES> AND ABC IS COMMITTING A CRIME AGIANST ME AND SO DID CENTRAL> I feel down yesterday and twisted my ankle. It is OK< but just because someone appears OK, does not mean they are. I hurt if I do too many stairs, but I was willing to deal with the pain becasue I loves what i was doing. I am a strong person, but I am human. I am honest and I love acting more than anything in the world. WHEN I had cancer, I signed up for a commercial class at Santa Monica College. When I had my car accident, I took VOice lessons. ANd the girl whose picture I sent you, told me she is a nurse and thought it would be easy to act so she would try it. I remember the look of guilt on her face when I told someone I was trained. I have spent 1000s on training. I auditioned and got into AADA (yes I know Blake Shields went there. I wrote him and told him about it. I never wanted to see him again, but I want to strive to be good at what I do. I was inspired by his kindness to me years ago. Blake is an alumni and he would not be there when I went anyways.) I shot my first film, but this happening is making it imposstible for me to take care of me. I can't go to an office and I can't get a job doing anythign I want to do becasue of what Central did.

This is horrible. I am in hell. I feel like someone has put me into a prison and I don't deserve to be there. I had an agent who was interested in me. She was an cancer advocate... what I wanted. Someone who would understand how important it was to me to be an artist and to help others. I truly don't deserve this. I did not strike back or reveal any secrets, until after I found out I lost everything. I went to a lawyer too and found out that aparently because I am being labelled crazy, no one will help me even though I know that what ABC did was wrong.

Clarification please. You told me that ABC told you I tried to get onto a lot where I was not supposed to be. The day this happened, security told me that I was on a watcher list. You tell me I tried to get on the lot when I was not supposed to be there, but you booked me for that day. Arnie Store told me the day before he was booked and then I got booked. Which is true???

A friend of mine has gotten me in touch with an attorney with the Attorney General's office to see if he can refer me to someone. I want my file from Central. And it is not too late for that. You said I worked on 75 shows for you, no bad comments. I am still that same girl. I have had Bill Paxton hit on me, as it turns out he may have been separated from his wife at the time, but that does not matter. I stopped working his show. I had Henry Labonte talking to me a year after Sleeper Cell, and he talked to me like he knew me already which makes me think that Blake talked. I am a nice girl. Edgy due to having very unnice men in my life, but I don't need a man with money in my life.

I am a smart girl and I will go SAG and I will be working. And if I find out that what you said is what is going around and you and I both know that is a lie. YOU booked me that day. I would not cause a problem during a shoot. You are probably right. Someone did take the whole Blake thing out of proportion, but don't regulate it to me being a fan, because even one of Nick Stahl's stand ins at the time told me he wanted me. I am a good girl. And I was not ready for anyone in my life. I am getting my self together, but I will do what I have to. DON't push me back into background or think that it is OK to say I did something I did not, or would not do. That is detrimental to my reputation, and though you were obviously lied to perhaps. I know the truth, and you know me well enough to know that I may be emotionally unstable now, but if I were so crazy, I would have speed shows by now, and I don't do that. So why would I go somewhere I am not wanted. I have speed 5 shows in the past 4 years probably. It is a rare thing for me to do. I think it is degrading and I don't like it. I've spent enough time on Grey's. I even used to go to a bar and run into the guy who plays the ghost on the show now. I was more scared he would remember me and tell people I was out at a bar on the weekend, even though I was not drinking and just out with a friend. I even saw him at the Scream Awards and I think he recognized me but I did not walk up to him. I probably should have, at least to say how sad I am that the bar is now closed, which is why I feel I can tell people. they can't stalk him at a place that does not exist anymore.

I did not come in to your office crying last week. I cried when I showed you the e-mail. But for the most part, that was a few tears, no hysterics. YOU also said that I tried to go to a set I did not belong. That is 2 lies and 2 distortions of the truth. I cried on the phone to you almost a year ago. YOU also told me that they told you never again on any ABC lot. Security told me I was on a watcher list. If what you are now saying is true, you did not tell me the truth last year, and I have spent this past year in misery. YOU know I am a cancer survivor. YOU heard me crying on the phone a year ago. My reputation and my work meant more to me than any guy could... I can't rely on a man to take care of me or pay my bills, and frankly I don't want to date anyone.

I NEVER DATED AN ACTOR PERIOD> >>I am friends with actors. >> AND THERE ARE INDIVIDUALS IN THIS TOWN I REFUSED TO DATE BECAUSE I WAS WORKING WITH THEM> I TOLD YOU I ONCE MET AN ACTOR FROM GREY'S AT A BAR< BUT I NEVER TALKED TO HIM ON SET OR AFTER THAT< AND FRANKLY IT WAS OUTSIDE OF A BAR AND I WAS THERE FOR AN ENTERTAINMENT SEMINAR AND HE WAS JUST SMOKING> IT WAS A BAR OUTSIDE OF THE LODGE WHERE HE WAS STAYING FOR PILOT SEASON>

I am a professional JEFF> I was and am. I have been sick and not well, but I am sick to my stomach that someone I have admired for years and taken to be a professional has taken to lying to me. I am here in LOS ANGELES to stay. This is my home. I have known that the only actor I almost crossed professional lines with has been out of my life since 2006 which is why I showed you that e-mail. I am disappointed in the fact that you are not being honest with me and that you have lied to me. I am a woman determined to take care of myself by working on sets. The very fact that you pointed a guy out to me in your lobby as cute and who I should date was an unprofessional act on your part. If what you say is true, then I was slandered and that is legally actionable. The only question is which is true--- what you are telling me now or then. Since I am determined to always work in this industry and to always strive to be an actress you have not seen the last of me here.. I get told I am on some list like a criminal when I never committed a crime and I would sometimes show up at Greys' when others would not. Professionalism means making money off what you did, as such I spent 4 years working as Background... the only reason I chose to fight cancer in 2005 was to continue to work in this industry. I am not being selfish for wanting to do what I love. Frankly I blame my cancer on years of doing what others wanted instead of being true to me. I don't work unless I am on a set, and I knew you were lying to me about being back on sets by this summer. I am honest Jeff. I don't play games and I was a hard working woman who rarely complained and knew my place on sets. I also have a law degree I will never use and as an educated woman I knew how to do my job well. Arnie Storr that day kept talking to me on set about being booked the next day, and I eventually got booked as well. I would not even make calls on set or answer my phone unless I was certain I would not mess up the situation. I even told Arnie that he really should not be using his phone on set the way that he was.

I only sent you those e-mails out of courtesy to your office, so I would not get upset with you directly, but so you would know what I thought of the situation, as opposed to hearing it from third parties. I never needed looking after. In fact, your stand in on Grey's can vouch for that- if she is being honest. I almost got involved with her ex-Johnny Ponzio- but he lied to me about her- and I refused to date him when we were working together, and later refused to when I found out he lied to me. I never was intimate with him. I spent the last 2 years on Grey's dodging bullets from Ms. Youngblood, including her telling the PAs that I was going for food when I was not supposed to, even though I had asked permission.
