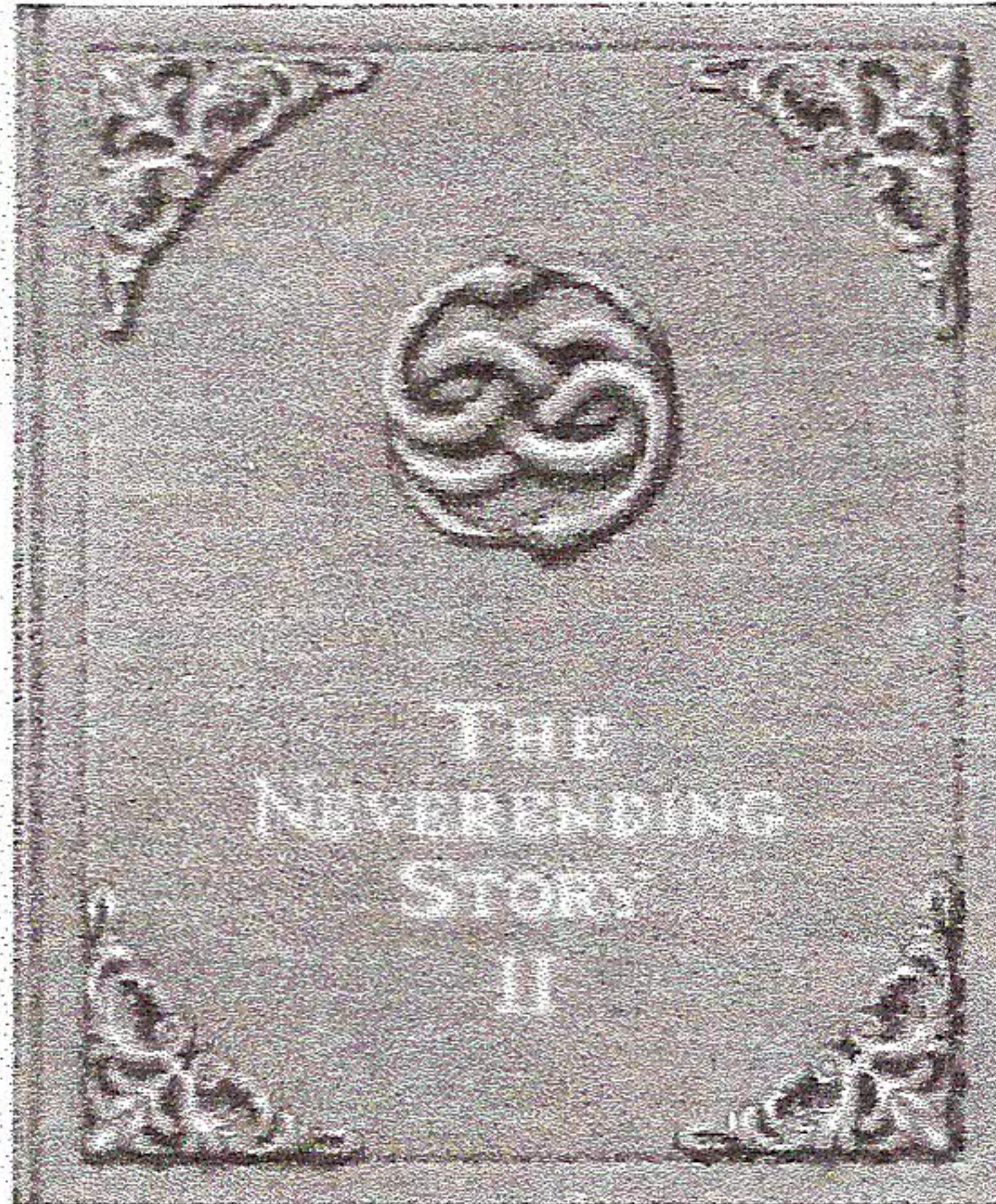

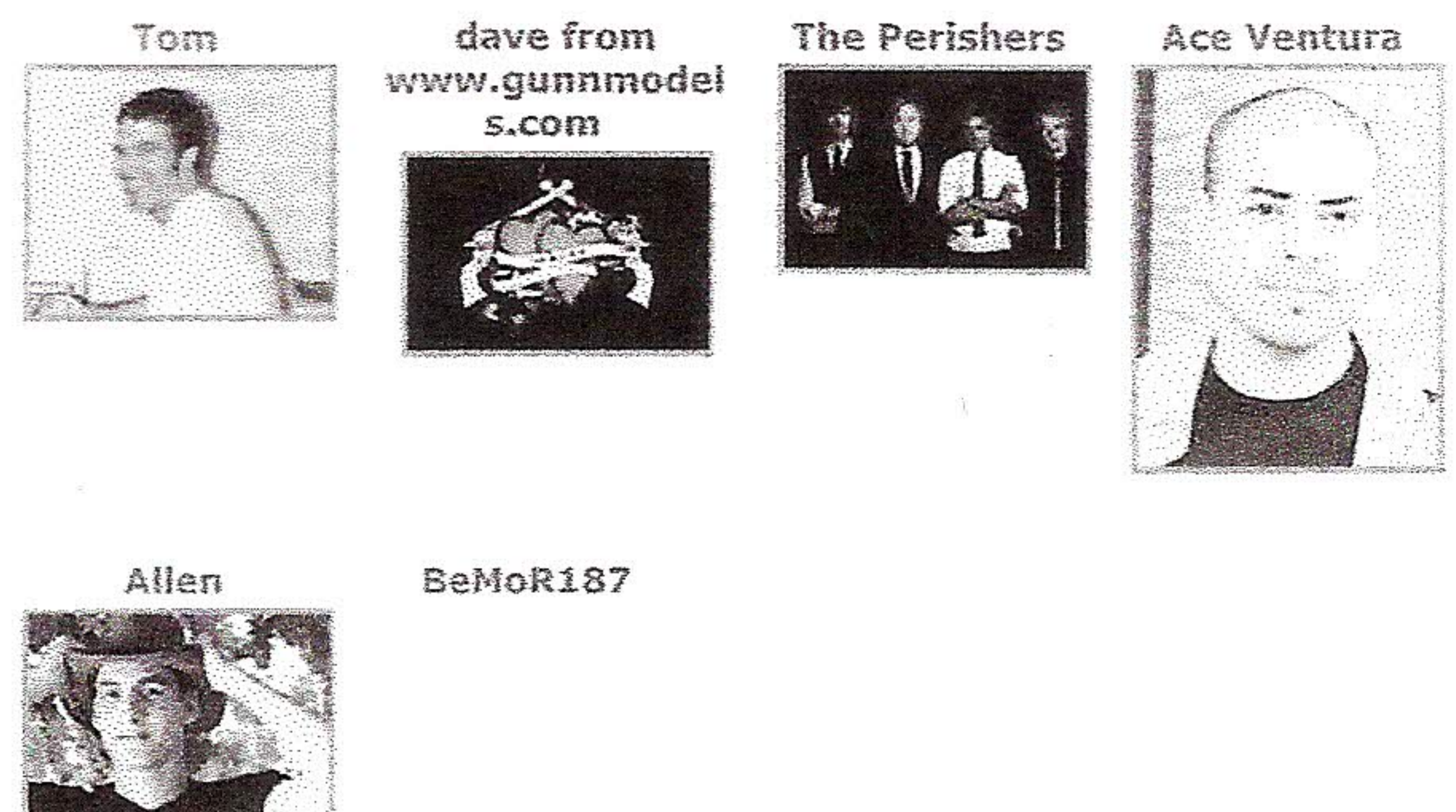

Subject: Never approach me on a set or bad mouth me while we are working together.

Body: Dear Mr. Jeremy Gilbreath:

I am writing you here on myspace to make you aware of my intent to file a restraining order against you should you violate my physical space again on a set. As you know, in 2005 we used to be friends. You and two friends of yours took me out and tried to get me drunk. You then proceeded to take me to a house up in the valley where your one friend tried to climb into bed with me, and then you attempted to molest me. You knew I was not interested in you at all in a physical sense. I never was, nor would I be. I recall even telling your girlfriend on numerous occasions that I preferred blonds, but what I should have said is I prefer class.

At first I took this as just you being drunk and under the influence. However, later that day you tried to jump out of a car with your girl friend driving and me trying to hold on to you in the back seat. After hanging out with you, I quickly discovered that you continued to get into my physical space. I also found your behavior so odd and since I witnessed you take two boxes of benadryl from your friend's house, I confronted you about possibly being still on drugs, and you accused me of being crazy. I shut off all contact with you at that point and I have not e-mailed, text or called you since early 2006.

In 2007 I worked on a commercial with you for shoebuy. com. At that commercial you continually got into my physical space. After 12 hours of this, I finally lost it with you and told you off and in front of everyone and told them how you had physically violated me when you were drunk.

Last week while working on a Verizon commercial you again got into my physical space. I felt so violated by you; I started to cry and lost it. I also heard you tell your friends that you did it on purpose and that you were going to go to the Ads to get me into trouble. You approached and got so close to me I could breath on you knowing full well how I felt and knowing full well how I would react. This was more than just discomfort to me considering it caused me to have to go to someone who had to take me out of the crowd so I could compose myself. Your behavior is outlandish and harassing to me. I don't want to be embarrassed, humiliated or tortured by you any more. As you know, I have no qualms about expressing my opinion of you should you get into my physical space.

I do not however want to cost you work, nor do I want to lose work because of you. I also heard you say you would commit suicide before taking a nine to five job, and frankly unlike other people in this town, I am not a killer. I have made it clear to BTS that I intend on filing a restraining order against you should you act this way again toward me. This removes BTS and the productions from the equation. If I file a restraining order the production will not need to monitor your actions, because if you come near me, I call the police or contact the courts to enforce the order. Your actions will get you into trouble, not mine. This way also you can not say in any way shape or form that I will burden the crew or production because you decided to violate me again and try to get me upset or get me fired. If you attempt to prevent me from working because of your actions and because of my intent, and I find out about it, I will also take legal action against you for slanderous and fraudulent conduct and I will seek restitution for any lost wages.

If you approach me within five feet, I will file for protection against you. In addition, I suggest you cease any form of harassing language or behavior within my presence. I am not interested in hearing your opinion of me or

my life or anyone from my past; this includes any personal interests or relationships of mine. I do not want the productions to have an excuse to fire or not hire either of us. Therefore, I suggest you do not slander me to any Assistant Directors, crew, or casting agents in the future, otherwise I will be forced to take further legal actions against you beyond just a restraining order. I find your conduct completely unprofessional and potentially dangerous to my well-being and person. Should you contact me back I will block you after receiving your e-mail. I have never been blocked by anyone, so I don't know the consequences to you, but I want it to be clear that I want no contact with you under any circumstances. I do suggest though that you may wish to seek legal advice or counsel, as I am an inactive attorney, I can not give you advice as to what steps you should take in this matter. I am simply informing you that should you slander me again, prevent me from working by slandering me to production, or violate my physical space again on a set, I will take action and what the consequences of that action may be.

I am printing out this e-mail in addition to your profile as a record of this correspondence.
