Dear Ms. Tull:

I, too, am pleased that you have been accepted to the Benjamin N. Cardozo School of Law for the session beginning August 1995, and I would be delighted to meet you before then. If you would like to visit the school, please call the Admissions Office a week in advance to arrange a personal visit to observe a class and tour the building.

In the meantime, I must advise you of several formalities that are necessary to secure your admission in the entering class. First, your admission is, of course, contingent upon satisfactory completion of undergraduate academic work which may still be in progress. It is a requirement of the American Bar Association that an **official transcript** documenting coursework and the receipt of your degree(s) must be on file. An official transcript constitutes a transcript certified by the issuing school and delivered in a sealed envelope directly to the law school no later than October 1, 1995. Copies of transcripts supplied by Law Services or student copies are not acceptable.

In order to hold your place in the entering class, we require an acceptance deposit of **\$300** which is due in this office and postmarked by **April 1, 1995**. The check should be made payable to Yeshiva University and mailed to the Office of Admissions at the above address. This deposit is applied toward tuition. Should you decide not to enroll, you must notify the Office of Admissions **in writing**. The deposit is partially refundable if the school is notified of your decision as follows:
