In 2008 i was tripped on a set so bad i could not bed my legs for a week. JT Thiboreaux? A stand in from Carnival was on set that day and i was told if i did not run all out id be fired. Within an hour after that i was in the hospital.

Jeremy Gilbteathe tried to rape me in 2006. He kept getting into my space. He had a drug problem. He was Nick Stahl's stand in who later also came out with a problem. Based on this essay by Blake Shields, so did he.

Seriously i got let go from a temp job once because i chose to go to my acting class as opposed to working all night on organizing my bossed address book even though i had no other projects to do. I will not Give up wanting to be on a set acting. I would have chosen to die of cancer if i knew america would favor rapists over education and honesty.

If you do nit believe me. This blog contains the emails between John Ponzio & myself. An email from the director friend of Jeremy Gilbreathe telling me to forgive him. Not accusing me of lying. That bastard probaby bragged about what he did and said i wanted it, which is BS. And An email i wrote Assaf Cohen who is on the union board in 2011 telling him i wanted his friend David Lawtence to leave me alone. David asked me out and i turned him down...Assaf, David & Blake

were all in the cast of Heroes . yep i knew or met actually about 7 members of that cast.
