I am tired of high school and unethical bullying behavior. do not tell people behind someone's back they have been fired without finding out what is really going on. Do not call someone weird. Do not say someone is not willing to work with you if you are not willing to communicate and be direct.

I was sexually assaulted by JEREMY GILBREATHE post having breast cancer in 2005. He had a girlfriend. i asked to be taken to my car. Instead he and his friend drove me to a house in the hills and I was stuck with them for the night. I was lucky he was too drunk to force himself on me. Jeremy was Nick Stahl's stand in on Carnivale. I have been dealing with PTSD every since. people with issues are protected. When you hear discussion of discrimination, that includes not bullying someone like me or anyone who is different, and i am only different in having a high IQ and a history of illness and abuse. Look up Hashimoto's. It is a disease that probably as many as 2 million people have in the US. I know there are at least 2 celebrities in their 20s who are working and dealing with it.

the Week of October 6th I went out to an event as I was volunteering at the AWARENESS FESTIVAL, a film festival in DTLA. That night I got attacked online. It was not the first time. I have been attacked over and over since 2014. Twitter accounts all. This person has said my chakras are mess up, they want to rape me, slash my face, I am going to die, I should end my life, and allot of other nasty things including references to me being a student and basically how I should not be. I have a right to be. Do you know I have met 3 other people like me at SMC with law degrees, four if I count a guy in my sound class who makes documentaries. YEP. there is a lawyer, maybe two, in my sound class this semester. Do you know how many women with law degrees are working as actors? None. There are no famous female actor lawyers, except Gloria Allred, but I am not sure she can count as a trained actor. If I were a MAN would I be treated the way I have been.

You see my main issue right now is the fact that there is a connection between these attacks and the students at SMC and it is horrible. Jeremy got his girlfriend pregnant so i think they drove me out because he needed to keep working and I was complaining about him. Well all he needed to do was to stop getting in my physical space. It is the old story. It is my fault because I am a woman, not his for being a creepy perv who kept getting so close to me he could breathe on me whenever his girlfriend was not around causing me to scream for him to back away.

Now it turns out an actor who once asked me for drinks, but nothing happened, Blake Shields Abramovitz, lives in Venice. he told me in 2006 he lived in the PALMS. I have lived in Los Feliz since 2005. I could have moved to the west side in 2006, but chose not to. Blake knows JEREMY tried to rape me. he has known since 2013. I have been taking classes at SMC since 2005. He knew Jeremy was harrassing me on sets in 2006. I have seen Blake 3 times since 2005. Once in 2013 I went to a place he was working to tell him everything that was happening and find out if he was involved. The twitter attacks claim Blake will make a million off of a play he wrote called DOUBLE BIND in which his lead character is named LAURA and her husband's name is FRANK. My ex is Frank, and I also have an ex named SAM. When I found out about the play I informed BLAKE I was angry and I did not want him putting the play on again unless his LAURA had a career and was not obsessed with holding on to her husband.

Now why do I bring this UP> Because I can not work with Carrie FINKLEA at this time or ANY TIME. I do not feel safe and frankly I do not think she will be fair to me as a producer. You see Blake works at a yoga studio now and because I am being attacked I did some digging. Blake's studio is run by people from Oregon. Carrie is from OREGON, no big deal. Blake also works with a woman whose favorite bar happens to be the bar that the director of the western Carrie helped produce works. I am being called WHITE Privilege and racist and being told to disappear and end my life while also being told that BLAKE will make a million from his play and JEREMY will rise from the ashes. Carrie is also signed with an agency that happens to rep JOHN CAROL LYNCH, who worked with me on CARNIVAL and CLOSE TO HOME, and KATE WALSH who is responsible for having me blacklisted at SAG FOUNDATION after I asked why I was blacklisted by GRAY'S ANATOMY. I am tired of being blacklisted and abused and dealing with someone who feels they have the right to do so because of their position is they are a known actor and I am left with fear. I have felt since day ONE Carrie was not in my court when it came to working on sets. It has only been recently that I have discovered the connection to the people who blacklisted me for false reasons. I should add KATE WALSH also knows a girl, CYNTHIA YOUNGBLOOD who had an issue with me over a guy she was dating who tried to date me while dating her JOHN PONZIO. John is Cynthia YOUNGBLOOD's ex. When JEREMY GILBREATHE got fired for doing cocaine, John got Jeremy's job as a stand in. . I found out and told

her off. that was in 2004 before I had cancer and when I was healthy.

I have never been arrested. I have never committed a crime outside a traffic violation. No DUIs. I do have a law degree but you do not have the right to make me use it. there is a woman in my sound class who I almost lost it with because she kept telling me I would make a good lawyer and it made me want to curl up in a ball and cry. I found out she happens to be from IRAN, well BLAKE happens to have spend time in ISRAEL.

I am ONE CLASS SHORT OF THE CERTIFICATE in FILM PRODUCTION. I am sorry but I did not fight cancer to be school marm or librarian. I am scared I will be bored and be stuck in a job I hate with no friends and no fun. that may sound irresponsible of me, but frankly if you told me you can not have a job you will love but you must make money, I would end my life. I would not want to live in a world where I could not be an actor or a film maker and I NEED TO BE BOTH. I can not live to work in a world where I lose all I worked for because I am woman and refuse to be in a relationship or because I am not in a relationship and sick I must be GAY. I am not. And I am not ANTI GAY. I am sick of this person attacking me and degrading me for being an actor and a liberal and for being a person who had a dream. I am sick of this person saying I am GAY and weird. As a woman with a law degree all of this violates my rights and it violates my peace of mind.
