I have been attacked on line and abused by staff, on particular Jewish staff in the entertainment technology department. Despite ill comments. I have managed to maintain a GPA of 3.67. I have been also viciously attacked on twitter. The attacks stopped this past semester after I dropped FILM 33 and informed the head of the film department that his associate producer Carrie Flnkelea has the same agent as two people in the industry tied to me being blacklisted.

I have an auto immune disorder. i do not currently have a job, but forcing me out of school instead of allowing me to get internships and grow in the direction I want with my dreams is fraudulent. the school has not right to police its students personal life. It certainly does not have the right to threaten or force students to do anything for a career against their will. You see the attacks have started again on twitter including telling me that 2017 will be the END OF ME.

Now as it stands I want to SUE the school for this. I want to sue them for violating my rights and for continued abuse due to my age and the fact that I am white.

It is no ones damn business what I do to make money but if I am going to get work I do not want people at SMC policing that. My future is one where I want to work in film and TV and be an actor, and I have GPA of 3.67 at SMC and I am not committing a fraud by being in school. I will not be FORCED TO BE A LAWYER and as a woman I am sick of being abused for being a woman with a law degree when MEN get to do what they want. I EVEN MET AN AFRICAN AMERICAN L:AWYER IN ONE OF MY CLASSES and in my sound class this past year there was a lawyer now documentary film maker. I lived in DC for ten years and my parents did not live with me or have anything to do with my life and my father has abused me.
