

OK..... I need you to explain something to me. Up until last night, I had a great deal of genuine respect for you. I was flattered that you asked me to work for you this weekend, and to join your scene group. Why did you act like a complete bully in class?

I understand miscommunications. You misinterpreted me today on the phone, and assumed TVI forced me to take your class....NOT TRUE! I needed a cold reading class, and yours fit my schedule. I did not want to take your class because I was scared. My reasons are personal to me, and none of your business. I have been to law school and I have been bullied by better. I was honest with you, and you disrespect my honesty by practically disclosing to the class that I was scared (which by the way Jasmine and the girls in front of me figured out who you were talking about.) I may seem clueless, but I do not miss much. You are a lawyer....I think that what you did was incredibly inappropriate. I am a dam good actress, but I am also a genuine considerate honest and decent human being. I am not a feminist, or a lesbian, but an equalitarian. And as you can tell, incredibly smart. (I am licensed in California). And as you could tell by my performance tonight, a very strong person with a great deal of integrity. I could have called you an ass in class. (Thank god for you I can act.)

So what is the deal exactly? I am not a quiter. I take it that my initial instincts were correct. 1) I should not be in this class, though I am good enough, because my instincts told me you did not want me there and 2) you do not really want me in your scene group. I just can not fathom, why you would offer me a position in the class, and than act the way you did tonight? Do you have an explanation?

For the record, life is way to short for me to waste time with petty back stabbing behavior. I do not typically participate in such behavior unless incredibly agitated with someone, or I feel the need to protect myself from the slings and arrows of others discontent. I am a loner, but not a bitch. I am also very direct. I think people in the class knew what you were doing, and I certainly knew. I just want to know why? And I am not quiting your class. In addition, I am doing a good job in your class, and should be able to become qualfied for cold readings.

Oh! And I am protective and loyal to my friends, regardless of sex, color or religion. I was defending Sarah yesterday to you, because your opinion of her was incorrect. If you want to write off other people like dust in the wind, that is your perrogative.

If you want to hate me for the above, and never call me for another audition, again that is your perogative. Frankly, I think you would be making a mistake. I can be good, and I think you know that. I can also respect you publicly, despite my current anger at your behavior. Frankly, I did not care if you called me for anything else. I genuinely liked you. What ever you want to say about me, I have guts, and even when I am scared, I have the capacity to face my fears dead on.

Thank you for the analysis, Miss Laura.

Funny you should mention that ... you hit on a few of my concerns before doing this:

#1 I didn't want the guys using the drug for self gratification, but realistically I think someone would, so I wanted to get that out of the way right away. I tried to make it so the audience would feel like the girls deserved it too (i.e. the chracter "Gordy" was nothing but nice to them in the beginning and they took

uncalled pop shots at him.) If you truly do relate to the movie attendant character, I have a hard time believeing you really "bonded" with the Gordy girls.

#2 Knowing I needed one person to do this, I wanted to get it out of the way quickly. I have never before cast myself in anything I direct. My money man insisted that I at least make an appearance in the film. Upon ageeing to do so for the first time, I wanted to find a way to get myself in and out right in the beginning and fast so I could re-concentrate on my directorial duties. I KNEW that Gordy would be a character to which many would take offense, hence more reason to find someone else to play him, but it was really the only one that allowed me to do what I wanted to do (I think you'd agree the bouncer or the guy losing his hair really wouldn't work for me).

You are, I am realizing more and more, very insightful. Thank you for your honest evaluation and again, thank you for coming.

Sorry I left class early yesterday. I hope I was not rude. I was tired and therefore cranky. I wanted to thank you again for the audition. I have a small gift for you. I have been carrying it with me for awhile. I just do not want to give it to you in front of the class, because no one likes the kid who brings the apple to the teacher. I am a nice person, and I do not want people to hate me for being nice. (This is not a bribe or a future expectation of other auditions, either.)

I am taking a script analysis class, so here is my take on your film. I liked your movie, but I was too tired to give a commentary on it yesterday. I had trouble sleeping. I would rate it R, if only for the (sorry) sleazy character you play. (Good job!). (I do not like men like that though, so I kind of wanted to see you get the boot or something at the end.- I mean your character.) It was very funny. I liked how the rest of your buddies used the "Spanish fly" to "help" others, sort of, for the most part in the name of playing games. My favorite was the "uncoordinated" movie employee, who ended up with a date with the bar tender. As a nerd in my own right, I am biased though. I thought it was a very sweet touch. I also liked how the one guy causing the most trouble, and having the most "fun" with the drug, ended up having the joke played on him by his female friend. Over all, I thought it was a fun romp, and a very unique piece. I have been trying to figure out its structure in my head, but what makes it unique is the fact that it is improvisational. A true blooded conservative script analyst may have difficulties with that. However, Ground Hog Day and Pulp Fiction did not follow the typical three act outline. I could argue that the instigating incident is the introduction of the drugs and the first use by the group for none self physical gratification purposes, ending the first act. The final moment leading to the conclusion consisted of a series of moments, starting with I think the drug distributor being powdered by his female friend, or what ever incident started the people waking up from the drug at the end. So I could argue that there is a three act structure, even if unplanned. It was entertaining. Well done Will!
